## N.J. Clinical Director at State Unit for Sex Offenders Sued by Female Psychologist of Sexual Harassment and Wins with a Lawsuit Settlement

Dear Press:

Please be advised I am sending you my story idea for news coverage about The Media's on exposing sexual harassment allegations, at the New Jersey Department of Human Services, (DHS) at the Special Treatment Unit (STU), in Avenel and how the Clinical Director at the State Unit for sex offenders Dr. Merrill Main, was sued by a female psychologist of sexual harassment and wins with a lawsuit settlement, but he is still working there after the lawsuit was filed against him, and won by a female psychologist.

Also please be advised pursuant to my lawsuit case in the Federal Court issued it's **Pretrial Scheduling Order** entered on October 18, 2017, and that the Defendants Merrill Main, Van Pelt and Beaumont are to file their Answer to Mr. Tinsley's First Amendment retaliation claims against these defendants; for Discovery, and for the up and coming court date proceeding. A hearing will be held at the Special Treatment Unit, Facility for violent sexual offenders and regarding Mr. Tinsley's civil commitment proceeding.

I am also writing you and requesting for you to respond to me about this matter as the News Media, and for the Press's on exposing sexual harassment allegations at The Department of Human Services, (DHS) at the Special Treatment Unit (STU) and how Dr. Merrill Main, is still working there and how this Clinical Director at the State Unit for sex offenders Dr. Merrill Main, who was sued by a female psychologist of sexual harassment and she won a lawsuit settlement, he is still working there after the lawsuit was filed against him, and was won by a female psychologist and for his:

1.) Being sued for sexual harassment by a female psychiatrist at the ("STU"), and the fact that he is a sexually violent predator himself and the son of an Alaska Sex Offender from the Archive Record for Joseph Ambrose Main, Appellant v. State of Alaska, Appellee, Court of Alaska 688 P.2d 868 (Alaska Ct. App. 1983).

Especially, after the (STU's) civil commitment court, and when their Treatment Teams and District Attorney General Cindi Collins stated at a Resident's hearing I.M.O. Civil Commitment M.O. SVP-464-07, on June 24, 2014, about a Resident talking about his family. "It becomes part and parcel of who we are our families". See Transcript: pp. 95 lines 1-2. I would think if this is the case about a Resident, and his family, then it shall not be limited to those matters relevant and proportional to the fact that Dr. Merrill Main is a predator himself and like his father was a convicted sexual violent predator.

Dr. Merrill Main conduct was very bias and unprofessional with female psychiatrists at the ("STU"), and there was an internal investigation on the relationship between Dr. Vivian Shnaidman and Dr. Merrill Main at the ("STU"), for sexual misconduct allegedly occurred when Dr. Vivian Shnaidman worked with him at one of two specialized institutions for sex offenders in Avenel;
- (3.) Dr. Main committed fraud and mismanaged funds in connection with his position as trying to build a case to fire Dr. Vivian Shnaidman from (DHS) and how he is managing the ("STU") Special Treatment Unit, in Avenel, New Jersey as the Clinical Director.
- (4) As Dr. Vivian Shnaidman was a Clinical Psychologist working with Dr. Main of ("STU") he was refusing to promote her, retaliated against her, and created a hostile work environment, all in violation of the Law Against Discrimination (LAD), N.J.S.A. 10:5-1 to-49. Please see In Lehmann, 132 N.J. at 603.

I am contacting the Press for a News' story that should had been covered, about Dr. Vivian Shnaidman involvement with Dr. Merrill Main and her lawsuit settlement against the DHS, and about her complaints sent to DHS's Office of Equal Employment Opportunity (EEO) that was not fully covered in The Press News Media.

You can directly review the legal cases about what Dr. Vivian Shnaidman told the courts about her involvement with Dr. Merrill Main and her lawsuit settlement against the DHS about her complaints sent to DHS's Office of Equal Employment Opportunity

(EEO). And the fact she was retaliated against because of her complaints, but Dr. Merrill Main is still working at the STU as the Clinical Director, and or after the fact that other female psychologists and psychiatrists also had complained where they works with Dr. Main (or used to work), never been covered by The Press?!

Especially, after I've already contacting the Press for a News' story that should had been covered, about Dr. Vivian Shnaidman involvement with Dr. Merrill Main and her lawsuit settlement against the DHS, and about her complaints sent to DHS's Office of Equal Employment Opportunity (EEO) that was not fully covered in The Press News Media.

In addition, the fact she was retaliated against because of her complaints, Dr. Merrill Main is still working at the STU as the Clinical Director and to the extent that she won her lawsuit the Press News' Media is now receiving this information and I am requesting your professional involvement to review this press release; or investigate all the complaints about the issues at the state unit ("STU") for sex offenders Residents and other staff members' matters of psychologists and psychiatrists about the ("STU") Special Treatment Unit, and the fact the State of New Jersey is still allowing Dr. Main to work there, and without the Press News Media full coverage story it would be a shame.

Especially after all the Press News' media coverage concerning women accusing employers of sexual harassment in the work place, NYT's on exposing sexual harassment allegations and after others High Profile Allegations, as well as more actors accused of sexual misconduct. The Harvey Weinstein's story, has nothing on Dr. Merrill Main, as the Clinical Director of the ("STU"), for sexually violent predator when he is one himself and the son of an Alaska Sex Offender from the Archive Record for Joseph Ambrose Main. See Joseph Ambrose Main, Appellant v. State of Alaska, Appellee, Court of Alaska 688 P.2d 868 (Alaska Ct. App. 1983).

I would like for the Press to do a Story Idea on this matter, and from your own experience as the Press and/or the Article Reporter News Media writers, on exposing sexual harassment allegations you can ask the question WHY?

I believe the Editors for The Press would like to do a Story Idea on this matter and from their own experience at the Press' News Media, and on their exposing sexual harassment allegations, can ask the question WHY? The State of New Jersey's Citizens are allowing the State's General Assembly's legislative acts be part of the evidence used to implement the New Jersey Sexually Violent Predator Act 30:4-27.24. et seq., in the first place and without full PRESS's News Media Coverage, of a Predator in charge of the ("STU"), and after the many complaints sent to DHS's Office of Equal Employment

Opportunity (EEO) and The PRESS's News Media requesting assistance to clean up the field of a corrupt civil commitment systems. The likes including:

A.)Dr. Natali Barone, a psychologist and the Director of Psychology at the STU, which was signed 93 STU residents, before her loss of licensure. Mr. Rodney Roberts who was wrongly imprisoned for 17 years, 10 in which he served at the Special Treatment Unit, under a wrongful civil commitment scheme and for a crime he did not commit that was featured in articles with The Star Ledger, by John O'Boyle and Mr. Thomas Zambito and on the Ms. Sandra King's Due Process TV Show – Segment of Rutgers Law School. There are other court challenges methods used in civil commitment as unconstitutional in the works. This court hearing is to deal with Treatment Issue being held as to (1) because of the publication of my book, "Civilly Committed", (2) my entertainment business career's website that Dr. Main call "would define as very much part of 'rape mentality'" and I am being punished for it here at the STU. Additionally, I am seeking to introduce the rebuttal testimony of my witnesses and from professionals' investigations in opposition of Dr. Main's justification to threatened me by and retaliated against me, and is providing discriminatory Modified Activities Placements ("MAP"), Treatment Refusal and because of my book and business career's website. All in violation to what MAP purpose is for. See: N.J.A.C. 10:36A-4 (10A:35-4) (2013) Resident rights subject to denial as MAP status as defined in this chapter: Also see:

MAP is a program generally reserved for residents displaying more volatile or problematic behavior. A more fulsome discussion of the MAP program can be found in prior opinions. <u>See Fournier v. Corzine</u>, No. 07-1212, <u>2007 U.S. Dist. LEXIS 54110</u>, 2007 WL 2159584, at \*8 n.11 (D.N.J. July 26, 2007).

The Press Media's news coverage is necessary for the Public to question Dr. Main's actions against Dr. Vivian Shnaidman lawsuit settlement and Dr. Main's opinion of my book and my business career website that is totally different from Dr. Main's clinical bias and unfair treatment at the STU's Treatment Team's prejudices among other things, that the institution's Clinical Director, and psychologists committed fraud and abused the civil commitment process, which deviated from that which I have shown in my comprehensive book and plans to pursue my entertainment business career. I would like to present these facts and newly discovered evidence, with the alledged victims Ms. Weeks, Ms. Davis and Ms. Adams' signed statements affirming their earlier oral Recantation statements to my out of state investigators, attorneys, courts and that they all consent to their names being mentioned in my book "Civilly Committed" the alledged victims recertified the truth of their Recanted statements.
