But, when a long train of abuses and usurpations, pursuing invariably the same goals, reveals a design to reduce them under absolute dictatorship, unconstitutional and illegal acts, it is their right, it is their duty, to remove such public servants, and to provide new guards for their future security. Such has been the patient sufferance of these citizens, supporters of Freedom, National Sovereignty, Democracy, Capitalism, the Free Market System.
