# **Director Report**


Activity tracking for Grants Committee: This is an area we have not explored previously but is essential in what the Grants Committee needs to apply for grants. Any event where you represent NAMI, help us estimate these key areas: Number of people reached, volunteer hours spent, cost of items/services and any in kind donation. An in kind donation is anything like free advertising, free space use, food or anything that would normally have monetary value. Please help me keep track, even small events like talking about NAMI to another organization count.

NAMI on Campus Event on December 5th: We have had some difficulty in reaching our previous point of contact for IWCC Council Bluffs and may need to seek a new POC. Our goals in this area remain the same.

Strategic Plan Highlight: earlier discussion about our strategic plan has been extensive, but I will take a minute to talk about our progress on priority # 1 "NAMI Southwest Iowa will continue to develop and strengthen the structure and function of the Board of Directors" This is why the Nomination and Bylaws Committee is so crucial to our success. We need to begin looking for potential board members as term limits approach and evaluating our bylaws is necessary to ensure they remain relevant in the future.

Fundraising Committee Update: Bigger event dates are on the agenda but I did want to touch on some great low effort ways to help NAMI. Amazon Smile is something we have talked about in the past, all you have to do is shop on Amazon (smile.amazon) like you normally would. We get .5% of your purchase as a donation. Hy Vee Giving Tag, this is as simple as buying the red giving tag reusable bag and indicating NAMI SWIA as the nonprofit to receive \$1. We have also talked about selecting NAMI SWIA on Facebook as your nonprofit to receive donations for you birthday, this has been wonderful when previous board members have done this. We also have the Paypal button added to the website that is set to launch. Please let me know if you need the link for Paypal or Amazon Smile so you can help spread the word.

Facebook Updates: I want to take a minute to talk through the importance of good content, sharing original posts and the reach it can have. The post below was made earlier this month and reached 24,386 people and had 559 engagements. Liking our posts does mean a lot, however when you share our post we have a chance to reach more people.



While the one on the left is a rarity in terms of reach it does not have to be. As a board, an affiliate and an organization we need to help spread the word about what we do. Additionally we have a need to create original content that helps us grow. When we simply share a post from another page it does more good for them than it does us. Partial online training is to be launched that will reduce the number of in person days for training. Results from IWCC event, about 30 people attended and Ciara Warden was guest speaker.
