

#### St. Augustine Shores Service Corporation November 10th Board Meeting Summary

"This Summary is a brief overview by the Observer Editor and is not the complete meeting minutes. Minutes are posted at the Riverview Club and on the Association Website.

The St. Augustine Shores Service Corporation's Board of Directors meeting was called to order by President Jim Priester at 7:00 P.M.

Minutes of October 13, 2016 were approved and Treasurer report approved. General Manager Smith explained the decrease in the operating fund and the increase in the reserve fund.

2015 -2016 Annual Audit was presented by Todd Neville, Neville, Wainio CPA's. He reported that the allowance for doubtful accounts has improved due to diligent collection efforts by Management and the Corporations Legal Counsel. He summarized the financial statements and reported a surplus for fiscal year 2015 - 2016. He explained that some special procedures were performed by his audit team that provided comfort to the Board and that this presentation was the annual check – up. Copies of the audit were available for the membership.

Managers' Report - Joseph H. Smith III

**Progress on Board Goals:** 

Curb Appeal - New plant stock will be planted at the entrances and the Riverview Facility the week of November 14th. Rye seed has been distributed in the medians. A new irrigation well has been installed at the main entrance. President Priester commented on the shoulder work that has been done to correct the issue with the drop off from the recently paved roads at the South entrance to the tennis courts and ball field.

**Safety and Security:** Tree removal has been the main focus to protect the membership. The three phases of the clean – up effort were summarized. Removal of trees from structures. Removal of trees threatening pedestrians and vehicles. Clean – up of downed trees from the common areas. The safety fence has been installed at the foot of the pier.

Operations: General Manager Smith reported that Hurricane Matthew had swept away approximately 110 feet of the pier and the gazebo. Yelton Construction estimates that it will take \$75,000 to \$100,000 to repair the pier using the existing wood and the pilings that can be salvaged. A total replacement would be around \$300,000. There is \$300,000 budgeted in the Reserve Replacement Fund. There is a disaster loan available for homeowners associations at a rate of 2.85 percent. The Board will solicit a written estimate and make a decision. Board Member Janet Cassford has resigned from the Board for personal reasons.

ACC Committee – General Manager Smith: 2 variances were brought to the Board. Sommers, 900 Viscaya Blvd. - Approved request for a variance to bring their fence 8 ft. forward of the rear of the house. Approved request by George Thanos, Deltona Corporation, 405 Maribella Ct. for setback of the pool. The ACC reviewed 8 applications: 5 fences, 2 new homes, 1 pool. Total approved YTD 275

Riverview Building and Grounds Committee – Holly: Suggestions offered for consideration: dry erase board for meetings; no pets allowed sign for the Kiddie Park; entrances to the Riverview Facility painted blue and the hinges and the hardware need to be replaced; pool table be removed from the Game Room

The Deed Restriction Review Committee - Charlie Bouton: Suggestions offered for consideration: Fences as a starting point; Sidewalks in the cul de sacs in Tuscany. Next meeting is January 9, 2016.

Did I say our group doesn't talk politics? There are members on both sides of the political aisle, but our group focusses on wild flowers, being outside, and enjoying the natural environment in and around St. Augustine. See? There is life outside of political differences. In October Hurricane Matthew cut short the fall blooming season. It blew away most of the blossoms of blazing stars and bushy asters and we're hoping there will be more next year. Under the hurricane's debris and all the grasses, coreopsis were hiding, though not by choice. We cleared away what kept sunlight from them, hoping they would bloom before the end of the season. Well, maybe next year.

In the upper end of the meadow near the path someone in our group strategically placed a bare branch because? Dragon and damsel flies like having a place to rest where they have a good view of their surroundings, so do the little anoles. The meadow isn't just for wild flowers; it's for all the pollinators and critters who have a role in the meadow and live there. The flowers that bloomed in October and November were golden aster, coreopsis, swamp sunflower, rattle box, Spanish needle, bushy aster, wild petunia, wire weed, casia, scorpion's tail, scarlet milkweed, and spider lily. The Elliot Love grasses and Muhly grasses weathered the storm without seeming to have suffered and, likewise


In the new year the Civic Association

#### **Estate Planning Tips** for Blended Families

Most of us need to do some type of estate planning, but it's especially important if you are part of a "blended" family. And the best time to start is now – before these plans need to be implemented.

Estate planning can be complex, so you will need help from a qualified legal professional. But here are a few general suggestions that can be suitable for blended families:

• Update beneficiary designations – and think about multiple beneficiaries. Update the beneficiary designations on your retirement accounts and insurance policies to reflect the reality of your blended family. These designations can supersede the instructions you provided in your will. So if your will states that your current spouse should inherit your assets, but you had named your former spouse, or a child, as the primary beneficiary of an IRA, then your former spouse or your child – not your present-day spouse – will indeed receive the IRA.

To ensure that "everyone gets something," you could name your current spouse as primary beneficiary and your children from a previous marriage as equal contingent beneficiaries. But the primary beneficiary will receive all the assets and is free to do whatever he or she wants with the money. To enact your wishes, you can name multiple primary beneficiaries and designate the percentage of the asset each beneficiary will

• Create a living trust – and consider a professional trustee. A living trust can help you avoid the time-consuming and costly process of probate, while giving you great freedom to determine how, and when, you want your assets distributed. After you pass away, the trust, if structured properly, can provide your surviving spouse with income for life; then, after your spouse dies, your children from an earlier marriage would receive the remainder of the trust.

So far, so good. However, issues can arise if you name your surviving spouse or one of your children as the "successor trustee" who will take charge of the trust upon your passing. Your spouse, acting as successor trustee, could choose to invest only in bonds for income, but if he or she lives another 20 or so years, the value of the investments within the trust will probably have diminished considerably – leaving your children with very little. Conversely, if you name one of your children as trustee, the child could invest strictly in growth-oriented investments, leaving your surviving spouse with greatly reduced income. To be fair to everyone, you may want to engage a professional third-party trustee. This individual, or company, is not a beneficiary of the trust, is not entitled to share in the assets of the trust, and, ideally, should have no "rooting interest" in how proceeds of the trust are distributed.

• Consider a prenuptial agreement. When it's time to settle an estate, a prenuptial agreement can help avoid disputes among members of a blended family. If you and your new spouse have agreed to keep your assets separate so that each of you can pass an inheritance to your own children, you need to spell out that separation in your "prenup," your will, your living trust and any other relevant estate-planning arrangements.

Above all else, share your estate-planning intentions with members of your blended family. You may not be able to satisfy everyone, but through open communications, you can help prevent bad feelings unpleasant surprises.







#### **Nerve Compression**

Stenosis is defined as "a narrowing or constriction of the diameter of a bodily passage or orifice." Spinal Stenosis is defined as "narrowing of the lumbar spinal column that produces pressure on the nerve roots resulting in sciatica and a condition resembling intermittent claudication and that usually occurs in middle or old age." (http://www.merriam-webster.com)

Such 'narrowing' can occur anywhere in the spine but is most often found in the cervical or lumbar spine, and its causes are varied. As the discs start to degenerate (DDD) the space between the vertebrae closes down. As the joints in the spine (facet joints) deteriorate the spaces can narrow. Osteophytes (little bony stalactites or stalagmites) can encroach on the space. In these cases the vertebrae approximate and the spaces either on their side (lateral foramen) place pressure on the nerve root or the space down the middle of the spine (spinal canal) narrows, placing pressure on the spinal cord.

Many people have wear and tear but not all have pain. Contributing factors might be trauma such as falls, motor vehicle accidents or a history of high impact sports. Other factors may include lack of spinal stability, weak abdominals, poor posture, muscle imbalances and carrying additional weight.

During an examination, physical therapists ask questions about function and pain. "Do you have pain with prolonged standing or walking that is relieved with sitting or bending?" I recently examined a woman who did not complain of pain in the neck but instead in the shoulder and arm. He pain worsened with rotation and looking up – both movements that cause further compression. She also has difficulty finding a comfortable position sleeping and has to get her pillow "just right"

Treatment for stenosis begins with identifying the level of compression, decompressing and treating the surrounding muscles. She was surprised how quickly this worked. After seven

weeks of pain she experienced a significant reduction during treatment and after. Her treatment consisted of heat, massage, traction and stretching. The heat allowed her to relax. The massage brought blood flow to the tight/sore muscles. The traction opened up the vertebral spaces, taking the pressure off the nerves. And the stretches allowed her to maintain the results post treatment.

She was treated for cervical stenosis but lumbar stenosis is treated much the same way: heat, massage, traction and stretches such as drawing one's knees to the chest to open the spine spaces up. Exercises are prescribed to provide the stabilization that was lacking. Simple modifications in daily activities may also need to be examined and modified including shoe wear for the lumbar spine and pillows for the cervical

Stenosis can be mild or serious. The sooner it is addressed the better so contact your healthcare professional today.


