The New Mexico Environment Department - Air Quality Bureau (AQB) wants to notify you of changes to the Universal Application Forms (UA1, UA2, UA3, and UA4), the Public Notice Guidance, and Public Notice Templates.

Timeline (2016):

- Public Comment on all these documents is due: April 11th
- NMED begin evaluation and implement of comments: April 11th
- NMED will re-publish, as necessary:
- Deadline for use of UA1, UA2, UA3, & UA4 in applications: May 18th
- Deadline for use of the new Public Notice in applications: June 18th

Summary of changes:

- In guidance, clarified the requirements for posting notices at the facility entrance
- In guidance, changed instructions for reporting greenhouse gas emissions
- In guidance templates, changed Hazardous Air Pollutant (HAP) reporting instructions
- In all templates, added AQB Spanish language contact information to end of notice

Summary of changes:

- **UA1:**
 - Require Title V specific information for both NSR and TV applications
 - Delete Question 4.b in Section 1.f. to identify NSPS/NESHAP/MACT subparts. This information is required in Section 13
 - Change the application hard copy and Compact Disk Submittal Instructions
 - Update the Table of Contents
- **UA2:**
 - Remove applicable state and federal regulations column from Table 2-A. Identification of subject equipment/processes should be reported in Section 13.
 - Add column to Table 2-A for engine type: 4SRB/LB, 2SRB/LB, CI
 - Change Table 2-P Greenhouse Gas Reporting Instructions triggered by promulgation of New Source Performance Standards (NSPS) for GHGs
 - Update Table 2-H instructions for reporting stack exit conditions for each operating scenario
- **UA3:**
 - Delete Section 22 Greenhouse Gas Applicability Determination. This change is due to the 2014 Supreme Court Partial Vacature of the GHG Tailoring Rule (Decision No. 12-1146) <https://www.epa.gov/nsr/clean-air-act-permitting-greenhouse-gases>
 - Change the Certification Section number 23 to number 22
 - Add Section 6a for Calculating GHG emissions
 - Revise Section 16 Air Dispersion Modeling
- **UA4:** New **Air Dispersion Modeling Report Section** (use only if modeling is required)
 - Created a separate form that requests air dispersion modeling report information. This will help applicants include information that is necessary to review air dispersion modeling reports and reduce the number of report corrections.
