Public Comment

- Jennifer Fidura, VNPP, presented state government updates
 - Caboose budget is approved, fully funding state government until June 30, 2014...do not have a budget for biannual to date, if no budget by June 30, they have no authority to fund government. Will fund state police, National Guard. Believe that they will fund Medicaid Waiver services and some nursing services in Medicaid only facilities at least because they are Medicaid dependent.
 - biggest issue is Medicaid expansion governor put a 2 year pilot toward Medicaid expansion dual recommendations offered in the house expansion would provide health options for those not at poverty level but unable to afford health care in VA. Jennifer will forward the link for secretary to email to the attendees to review bipartisan proposals. Issues adding to the discussion of Medicaid expansion is that federal dollars for indigent pay of medical services in the hospitals (DSH Payments) have been removed. VA is using state general funds for this, however it is state funding now covering what the federal government was.
 - Legislation related to Senator Creigh Deeds tragedy, formerly single family residential (8 beds or fewer) staff were called resident counselor = live in has been amended to no longer require that the staff live in the home.
 - licensure change if a provider is placed under provisional license they now have a right to appeal
 - any full license will be granted for either 1 year or 3 years, no longer 6 month licenses or 2 year licenses for MH providers
 - licensure changes effective July 1, 2014

- new legislation Senate Bill 77 allows for a non-family member who is willing to be able to claim a dead body in the event that the individual does not have family.
- Chuck Collins psychiatric admissions spike after the Deeds case. WSH has 28 beds per unit, generally have 26 full beds. Larry Hastings passed, was LHRC member for UVA.
- Pat Grizzel Dan Jenkins is moving to Waynesboro DePaul Community Resources Residential Program as Branch Director. Pat Grizzel will move to Risk and Compliance manager.

Affiliate Presentations Augusta Health Crossroads

Laura Pallin

Taken care of about 1000 patients, average daily 12 for geriatric, 38 on general side. Average 5 days length of stay. They have been receiving transfers from all over the commonwealth. Bed registry enacted this year keeps track of available beds in VA. Augusta Health is an acute assessment center. Average 3 admissions/3discharges daily. They involve Chuck Collins in all complaints. General complaints are that patients come in on a voluntary basis but ½ of patients come in TDO. This then leads to a court cases and involuntary commitment. These are usual complaints. Patients are going to WSH for assessment. Appeal process is available but usually the patient is not on the unit long enough to appeal. Most of the time patients could be committed up to 30 days, but can only be kept on a TDO for 3 days and by then the medications begin to work and are discharged. 0 allegations of abuse/neglect. Patient satisfaction surveys which are given upon discharge are generally 9.1 out of 10. They uphold confidentiality – group discussion ... some concern if this does violate confidentiality. It was determined that the patients are informed that group is voluntary, can request independent counseling. Staff are urged to make confidentiality statements such as everything stays here, don't share what you don't want people to know. Complaints go to Laura first then to Beth Chadwell, then Sylvia fletcher. Chuck Collins is included on all complaints. 7 incidents of assaults, patients to staff. 1 minor peer to peer but no injury and no need to report. Annual training is held in March.

DePaul Community Resources- Outpatient Counseling
