Attention e-Bay & Paypal Business Account holders!

Canada Revenue Agency (CRA) has been obtaining account holder payment information from e-Bay for several yr. (a handy reference forum: <http://forums.redflagdeals.com/does-cra-tax-ebay-sales-things-we-sold-ebay-1338211/>)

Now CRA has formally requested income data for PAYPAL business account holders. Link to news story: <https://globalnews.ca/news/3863284/cra-paypal-business-accounts/>

“...Specifically, the CRA is seeking PayPal’s list of Canadian clients who have a commercial account, including the total value of their transactions (purchases and sales) from 2014 to the date of the requirement (Nov 2017),” he said.”
