Financial Report and Budget Summary: Approved and filed for audit.

Bill Summary: Jane Baine questioned bill for flags. City Clerk, Brandi Miller, stated she copied our previous orders to have two extra of each size. Brandi additionally pointed out more charges related to the Schuber Mitchell project. David shared section 500.060(f) of

our code provides right to recover fees. Consensus was to hold on paying fees related to Schuber Mitchell project for one more cycle. Police Report: Chief Kitch presented report. Motion made by Chris Ellsworth, seconded by Barbara Welch, to authorize the sale of 812 for \$4,400 with light bar. Old Business: Update on FEMA/SEMA: David Weaver stated we should be receiving another \$80,000 for the second appeal soon.

All Seasons Signs: Aaron Garman was given an extension until July meeting to resolve setback violation. Nothing has been filed with the city. City Attorney, Mike Talley, stated business can be cited. Board requested letter be mailed to All Seasons Signs from City Clerk or Mayor giving deadline of August meeting.

Surplus Items Auction: All but two chairs were sold. Motion made by Barbara Welch, seconded by Jane Baine, to approve disposal of two leftover chairs. Ayes: Aldermen Baine, Welch, Ellsworth. Nays: none. Motion carried.

Update on City Matters: David Weaver discussed the regulatory agreement on the grant houses. He requested a motion granting Mayor authorization to sign request from the title company to move from Construction loan to first mortgage on CDBG homes. Mike Talley stated this is redundant with the regulatory agreement, but they require consent in writing. Motion made by Chris Ellsworth, seconded by Barbara Welch, to authorize Mayor to sign all requests. Ayes: Aldermen Baine, Welch, Ellsworth. Nays: none. Motion carried.

Aldermen Interaction: Alderman Welch requested we research if the court is cost effective for the city. She has requested Brandi create a list of Vendors by expense. Suggested a brainstorming session in regard to the budget process. Jane Baine asked about Sewer increase. She additionally asked about the street cut on 10th street. Mayor Heilbrun received email from Ray Brown requesting use of City Hall for training. Motion made by Barbara Welch, seconded by Jane Baine, to allow City Hall to be used only for activities related to city government. Ayes: Aldermen Baine, Welch, Ellsworth. Nays: none. Motion carried.

Public Comment: Val Carter, 4101 E. 20th St, spoke about Street Cuts, Piper Glen Curbs, All Seasons Signs, and Fireworks

James Morris, 278 Rose St, Asbury, spoke about Piper Glen curbs, ABC Supply Fence – Setback Variance. David Weaver stated they will need to have a stormwater review.

New Business: Sami's Business License: David Weaver stated Sami's has been operating without a business license all year. They have had an issue providing a No Tax Due letter. They have notified the City that they are working on a change of ownership.

Fireworks: Chris Ellsworth requested July 1st to 11pm on July 4th for shooting fireworks. Sales end on the 5th at Midnight. Mike Talley stated would have to be passed by Ordinance. Barbara Welch stated needs to also restrict fireworks when there is a no burn notice.

Utility Cut Bids: Brandi Miller stated document has been revised by Mike Atkinson at Allgeier Martin. Question on page 3. Mike Talley stated strike words "from item 1.3 and 1.4".

Update on Commissions and Committees: Alderman Welch updated on the park. There have been no hits on letters. Alderman Ellsworth stated P&Z conducting work sessions on accessory building issue. David Weaver stated having some issues with bank on CDBG project. There will be seven more houses this round.
