

A Public Hearing on the 2022 Preliminary Budget for the Town of Addison was held on Thursday, November 4, 2021 6:00pm at the Town Hall. The following people were present:

Proof of Notice having been furnished, the Public Hearing on the 2022 Preliminary Budget was called to order at 6:00pm. Deputy Supervisor Thompson asked all to stand for the Pledge of Allegiance.

Deputy Supervisor Thompson asked if anyone wanted the Budget read line by line, all board members and attendees declined. Deputy Supervisor stated that budget needed to be amended to account for an underpayment to the Campbell Fire Dept. in the amount of \$225.00 for the years 2020 (\$75) and 2021 (\$150), Account Number SF3410.4. Deputy Supervisor Thompson then asked if anyone wanted to speak in favor or against the 2022 Preliminary Budget.

The following person spoke against the budget:

Jeff BeGell – Doesn't like the way CHIPS funds are being used

All persons desiring to be heard, having been heard, the Hearing was terminated. Board moved to regular meeting at 6:11pm.

Motion by Councilperson Weale, seconded by Councilperson Lyons to amend the budget to reflect an increase of \$225 for a total of \$1625 for the Campbell Fire Dept. account SF3410.4. Roll Call taken: Thompson – Aye; Lyons – Aye; Weale – Aye; and Conklin – Aye. Motion Adopted 4-0.

Motion by Councilperson Lyons, seconded by Councilperson Weale to Adopt the 2022 Budget as amended. Supervisor - \$6,000; Town Clerk/Tax Collector - \$21,250; Superintendent of Highways - \$52,000; Town Justice - \$9400; Councilpersons – 4 each @\$1200 - \$4800. Total to be raised by Taxes is \$430,314.14 which is a 0.118% increase. Roll Call taken: Thompson – Aye; Lyons – Aye, Weale – Aye; and Conklin – Aye. Motion Adopted 4-0.

Motion by Councilperson Weale, seconded by Councilperson Lyons, that the meeting be adjourned at 6:14pm, and next scheduled meeting is Monday, November 15, 2021 7:00pm at the Town Hall.
