Motion by McCarty to accept the Agenda with the additions of the audit and the gravel review, supported by Kelly. All Ayes

Motion by Kelly to accept the August 14, 2019 Regular Meeting Minutes as presented, supported by McCarty. All Ayes

<u>Assessor Report</u>: Brothers Jason and Jeff McConnachie are being taxed as industrial for their solar installations and they should be Ag. Non Personal. Theresa Hendershot believes she hasn't been paying property taxes since 2012 or 2013 on 9 acres that was supposed to be split off 99 acres. She will be sending a property description and then a land division will have to be completed.

Z. Administrator Report: Jim Klaty wants to create a private cemetery, he can do so up to 1 acre with the proper road frontage and a land split. He'll need to contact the State Licensing and Regulatory Affairs also. We have permits for Eddie Moyer for 30X40 w/ 10' overhang on Custer Rd., Debra Sweet for 18X20 on O'Connell Rd., Matt Fahs for 30X48X12' on Maple Grove Rd., and Dave McConnachie for 60X120 on Forester Rd.

Motion by Sonck to pay Dickens \$208.33 a month plus arrears of 5 months for Z.A. duties, less withholdings, supported by Kelly. All Ayes

Sonck will call Wrathell about Mr. Lapp living in a trailer without water, electric, or sewer. The Health Department will need to be involved also.

Innes read the Treasurer's report into record as of August 31, 2019. General Fund account balance \$1,596.81, Investment account balance \$109,490.22, Tax Checking account balance \$310.10, Tax Savings account balance \$36,255.01. The balance difference in the General fund and Investment account from August 31, 2018 to August 31, 2019 is -\$6,741.18. Lee Eggert thanked Innes for the copy of the Township Audit. It was very concise and easy to follow and we're honest.

Communications Received: Innes received a Franchise Agreement from Thumb Electric.

McCarty received a call from a Pigeon phone number wanting the blight at the McGregor Hardware taken care of.

Hewitt received a call from a resident stating that the Sweet Extension Drain was being redug.

Sonck talked to Supervisor Essenmacher of Worth Township about their plight with the Drain Commissioner over their 42 million dollar sewer system that has multiple failures. Sonck also talked to our attorney's and told them we would drop our suit against the Drain Commissioner and

McCarty also received a call from a Sarah Walker wanting the Zoning Administrator's number as she had questions about zoning.

Meetings Attended: McCarty and Deputy Sonck attended the County Clerk's Association Meeting on September 12, 2019 where we discussed the 2020 elections. The kickoff is going to be January 9, 2020 and we could see 4 elections, as the schools seem intent on having their own May election. An increase in postage is to be expected as more people will likely be requesting absentee ballots with the passing of Proposal 18-3 and there's been a steady stream of voter registration cards coming through the office.

Hewitt attended the Bridgehampton Township Planning Commission meeting where the hot topic was blight. The consensus was that the fines and penalties need to be increased.

Old Business: Dickens talked to Wilke from the Health Department and he said if there is someone living on the Ruth Rd. property he will ticket them and they have 14 days to vacate the property or there will be an arrest warrant issued. Dickens had to provide pictures to Wilke to prove someone was living at the Ruth Rd. property. Dickens also was giving notice for the 9 vehicles on the property which violates the blight ordinance.
