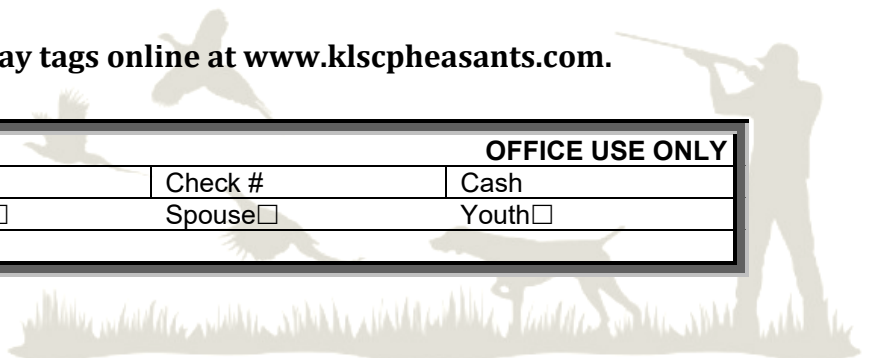

The River Garden Farms and Sutter Basin hunting areas have approximately 18,000 acres where pen-raised roosters are released. Associate Membership is **\$300.00** and Spouse/Junior tag is **\$75.00**. Make checks and money orders out to KLSC. Membership is limited to 250 Associate Members. **\$35.00 fee for returned checks.**

1. The hunter agree to indemnify and hold harmless the Knights Landing Sportsmen's Club, Inc., River Garden Farms, the Landowners, KLSC Officers, Agents, Servants and Employees from any and all claims, causes of action, suits occurring or resulting from any damages or loss to any person(s), including all persons to whom the hunter may be liable from any loss, damage, cause of action, claims or suits for damages whether intentional, negligent or arising from products liability, including but not limited to loss of property, goods, wares or merchandise, caused by, arising out of or in any way connected with the exercise by the hunter of the privileges herein granted.
2. The hunter agrees that the Knights Landing Sportsmen's Club, Inc., River Garden Farms, The Landowners, it's Officers, Agents, Servants and Employees shall not be responsible for any claims, causes of action or suits accruing or resulting from any damage, injury or loss to the hunter arising out or in any way connected with exercise by the hunter's usage of any privilege herein granted when such damages results from actions or activities on the part of any person or persons not associated with the Knights Landing Sportsmen's Club, Inc.
3. The hunter will be allowed to let a family member or friend accompany them as a non-hunting person only. The hunter accepts all responsibility for any and all damages caused by said non-hunting companion.
4. The hunter understands that members caught following the release vehicles are subject to immediate and permanent termination of membership in the Knights Landing Sportsmen's Club, Inc.
5. Overnight camping on hunting grounds is prohibited unless has written permission from landowner.
6. The hunter understands that any false information on this application will result in rejection of said application and termination of membership.
7. The use of all-terrain vehicles (ATVs) is prohibited unless the hunter is disabled and licensed by the California Department of Fish and Wildlife (DFW) to use an ATV to hunt upland game. The hunter must notify the Knights Landing Sportsmen's Club of the use of the ATV and provide a copy of the DFW license prior to the use of the ATV.
8. The use of night vision devices is prohibited.
9. Driving on farmer roads in the River Garden Farms is prohibited during the hunting season. Driving on farmer roads may result in termination of hunting privileges.
10. The use of copied back tags may be considered fraud and violators may be prosecuted.
11. Please keep a copy of this completed application for your reference.
12. Requests for a refund(s) must be submitted to the KLSC in writing and must be received prior to opening day of pheasant season. If back tags were issued they must be returned before the refund will be processed. Refunds **will not** be provided after opening day.
13. Back tags for junior (17 years and younger) and spouses are available at \$75.00 each. Please provide their information in the space provided. The Associate Member is responsible for the behavior of youth and/or spouse members, and accepts all responsibility for any and all damages caused by said youth and/or spouse members.
14. KLSC does not allow hunting all day the Wednesday prior to Thanksgiving or Fridays before a pheasant plant. The KLSC will release pheasants on select weekends only (weather permitting), but you may hunt both hunting areas the ENTIRE general pheasant season. Plant days will be posted at the clubhouse and on KLSC webpage and Facebook pages, and may change at short notice. It is the member's responsibility to know when plant days are.
15. KLSC offers a one-day pass for \$100.00, and a two-day pass for \$200.00. Tags must be returned to the KLSC clubhouse at end of hunt. A \$25 deposit will be collected when day tags are issued and will be returned if tags are returned to the KLSC clubhouse on the last day of the hunt.
