

HARWICHPORT RESORT COVID-19 MASSACHUSETTES and Village of HARWICHPORT TRAVEL ORDERS

All individuals entering Massachusetts after 12:01 a.m. on September 25, 2020 who are over the age of 18 or an unaccompanied minor must complete and submit the on-line [Massachusetts Travel Form](#) unless the individual meets an exemption below:

- 1. Lower-risk State:** This includes individuals coming from a COVID-19 lower-risk state within the United States, as detailed below. The current list of COVID-19 lower-risk states includes **Hawaii, Missouri, Oregon, Puerto Rico, Washington State**

- 2. Persons Exempt from Travel Order Requirements: Persons Who Tested Positive within 90 Days of Arrival to Massachusetts and Successfully Completed Isolation: Individuals who are COVID-19-recovered, meaning individuals who tested positive more than 10 days but less than 90 days ago and who do not have symptoms, do not need to obtain a negative PCR test prior to traveling to or quarantine upon arrival to Massachusetts. COVID-19 recovered individuals arriving in Massachusetts must have documentation of the positive PCR test result available if asked. This exception does not include COVID-19-recovered individuals who have symptoms of COVID-19, who must follow all testing and quarantine guidance outlined in the travel rules.**
Persons Who Have Been Completely Vaccinated for COVID-19: Individuals who have received two doses of either the Moderna or Pfizer COVID-19 vaccines OR who have received a single dose of the Janssen vaccine, more than 14 days ago and who do not have symptoms, do not need to obtain a negative test prior to traveling to, or quarantine upon arrival to, Massachusetts. COVID-19 vaccinated individuals arriving in Massachusetts must have documentation of their vaccination(s), including the date(s) of administration, available if asked. This exception does not include COVID-19-recovered individuals who have symptoms of COVID-19, who must follow all testing and quarantine guidance outlined in the travel rules.

Those who do not meet the above qualifications are not exempt from Travel Order:

- **Transitory travel:** This includes people who are passing through Massachusetts and permits travelers to drive through the State or to connect to their airplane, bus or train, or to stop at a highway rest stop, but this exception extends only so long as is reasonably required for the traveler to complete their transit, make any necessary airplane, bus, or train connection, or make use of travel services such as at a highway rest stop.
- **Persons Commuting for Work or School:** People who regularly commute, at least weekly, outside of Massachusetts to a fixed place to attend school or work or any person who regularly commutes, at least weekly into Massachusetts to a fixed place to attend school or work; provided that in either case, this exception applies only to and from the person's residence and place of work or school. Workers or students who travel to any place that is not their home state for personal or leisure reasons cannot rely on this exemption.

MASSACHUSETTS COVID TRAVEL ORDER

Those who do not meet the above qualifications are not exempt from Travel Order (cont.):

- **Patients Seeking or Receiving Medical Treatment:** Patients who are traveling to Massachusetts to seek or receive specialized medical care from a physician located in the Commonwealth and persons accompanying and providing needed support to the patient.
- **Military Personnel:** Any person who is required to travel to Massachusetts at the order or directive of a Federal or State military authority.
- **Workers Providing Critical Infrastructure Services:** Workers who enter Massachusetts to perform critical infrastructure functions as specified in Version 3.1 of the listing published by the Federal Cybersecurity and Infrastructure Security Agency are exempt from quarantine while they are commuting to or from or while at work. For the first 14-days after arrival, when the worker is not at work or commuting to work they must quarantine. Workers who travel to or from Massachusetts for personal or leisure reasons cannot rely on this exemption.

If you do not meet one of the exemptions above, you must complete and submit the online [Massachusetts Travel Form](#).

Failure to submit a completed [Massachusetts Travel Form](#), when required, or failure to comply with the quarantine requirement, if applicable, **may result in a \$500 fine per day**. HARWICH PORT— In an emergency order issued Tuesday, the board of health mandated that masks be worn in the heart of the village.

Masks are required along Route 28 from Bank Street west to Lower County Road. The area is a small but busy section of the village with a lot of pedestrians, said Health Department Director Megan Eldredge.

The new mask zone order is in effect. Face covering is mandatory from 9 a.m. to 10 p.m., except when people are eating or drinking. The emergency order provides for a warning with the initial violation, but a second violation will bring a \$200 fine, and a \$300 fine for a third violation.
