REGULAR AGENDA:

Resolution No. 5-1-2021: "To approve the minutes from the April 20, 2021 City Council Meeting."

A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmembers Topper, Tzan, Karpiak and Keedy and Mayor Lincoln. The majority of the votes being affirmative, the resolution was adopted.

Resolution No. 5-2-2021: "To waive the Four-Day Resolution Rule to allow for items submitted after the Four-Day Rule to be read at the meeting tonight, such Resolutions will be marked with an asterisk."

A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmembers Topper, Tzan, Karpiak and Keedy and Mayor Lincoln. The majority of the votes being affirmative, the resolution was adopted.

MAYOR LINCOLN:

Police Department Report

Pastor Matt Goldsberry led prayer in response to Councilman Topper's grandmother passing away.

Mayor Lincoln stated Community Ministries will be having a Volunteer Appreciation Day and requests use of the lot behind the ministries building.

Resolution No. 5-3-2021: "To grant permission to Connellsville Area Community Ministries to use the parking lot behind Community Ministries on July 31, 2021 from 1 PM until 5 PM."

A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmembers Topper, Tzan, Karpiak and Keedy and Mayor Lincoln. The majority of the votes being affirmative, the resolution was adopted.

Resolution No. 5-4-2021: "To approve a "Loading/Unloading Zone" on North Alley next to Riverview Apartments as requested by the Connellsville Housing Authority. Paint, signage and work to be taken care of by the Connellsville Housing Authority."

A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmembers Topper, Tzan, Karpiak and Keedy and Mayor Lincoln. The majority of the votes being affirmative, the resolution was adopted.

Resolution No. 5-5-2021: "To remove the Mayor and Police Department representative as voting members in the Diversity and Inclusion Board Bylaws."

Mayor Lincoln explained the board had reservations concerning a City employee and himself being voting members and that it wouldn't seem they are a separate board. He noted he will be the Advisory Member for City Council. He concluded two members of the police will be non-voting members.

A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmembers Topper, Tzan, Karpiak and Keedy and Mayor Lincoln. The majority of the votes being affirmative, the resolution was adopted.

Resolution No. 5-6-2021: "TO APPROVE THE REVISED RESOLUTION OF THE CITY OF CONNELLSVILLE CREATING AND AUTHORIZING THE CITY OF CONNELLSVILLE DIVERSITY AND INCLUSION BOARD."

Solicitor Witt stated this resolution is required due to Mayor and Police Members being removed as voting members.

A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmembers Topper, Tzan, Karpiak and Keedy and Mayor Lincoln. The majority of the votes being affirmative, the resolution was adopted.

Resolution No. 5-7-2021: "To approve the bylaws of the Diversity and Inclusion Board."

A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmembers Topper, Tzan, Karpiak and Keedy and Mayor Lincoln. The majority of the votes being affirmative, the resolution was adopted.

Resolution No. 5-8-2021: "To appoint Toni Colland to the Diversity and Inclusion Board; term to expire 2022."

A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmembers Topper, Tzan, Karpiak and Keedy and Mayor Lincoln. The majority of the votes being affirmative, the resolution was adopted.

Mayor Lincoln stated the next resolution is due to her having to travel and not being able to attend all meetings. He added Pastor Stafford, who lives in the City and was in attendance and expressed interest in being a voting member.

Resolution No. 5-10-2021: "To appoint Pastor James Stafford, Jr. to the Diversity and Inclusion Board, with Term to expire January 1, 2023."

A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmembers Topper, Tzan, Karpiak and Keedy and Mayor Lincoln. The majority of the votes being affirmative, the resolution was adopted.

Resolution No. 5-9-2021: "To accept the resignation of J'Taya Pirl, from the Diversity and Inclusion Board effective immediately."

A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmembers Topper, Tzan, Karpiak and Keedy and Mayor Lincoln. The majority of the votes being affirmative, the resolution was adopted.

Mayor Lincoln explained the following resolution as the Police Chief being contacted by PennDOT and being told PennDOT has new policies which will make it difficult to have Crawford Avenue shut down. He noted the Chamber had previously requested to use Crawford and know they are requesting Third Street instead.

Resolution No. 5-11-2021: "To close South Third Street between West Crawford Avenue and South First Street from 5 AM until 11 PM on Thursday, August 5, 2021 for the Savor the Avenue 2021 Event; pending review and approval of Police Chief and Fire Chief."

A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmembers Topper, Tzan, Karpiak and Keedy and Mayor Lincoln. The majority of the votes being affirmative, the resolution was adopted.

Resolution No. 5-12-2021: "To grant the Honor Roll Committee permission to place the Honor Roll on the site of the War Memorial at the intersection of North Pittsburgh Street and Rt. 119."

Mayor Lincoln stated Mrs. Keller put a lot of time and work and research into making the memorial a reality. He further noted she has gone above and beyond. He also stated she did research on the veterans and who would be listed on the memorial and the cost of the granite. Mayor Lincoln stated the Connellsville Festival Association will be a part of the fundraising for this.

A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmembers Topper, Tzan, Karpiak and Keedy and Mayor Lincoln. The majority of the votes being affirmative, the resolution was adopted.

Mayor Lincoln stated they will table the vacating an alley at Penn Street.

City Clerk Ohler stated the next resolution is Highland's Hospital upgrading the ER project.

Resolution No. 5-13-2021: "To approve the Cooperation Agreement with Highlands Hospital and the Redevelopment Authority of Washington County for RACP Funding; to authorize and direct the Mayor, City Clerk, and City Solicitor to execute such Cooperation Agreement; and to authorize and direct City officials and employees to take such steps as may be necessary to effectuate such Cooperation Agreement."

A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmembers Topper, Tzan, Karpiak and Keedy and Mayor Lincoln. The majority of the votes being affirmative, the resolution was adopted.

Resolution No. 5-14-2021: To grant permission to the Diversity and Inclusion Board for use of Veterans Plaza on Saturday June 19th, 2021 from 1 pm until 2 pm for the Juneteenth Program and to close North Arch Street from West Crawford Ave to Orchard Alley at this time."

Mayor Lincoln thanked Melinda Powel and Scottdale Bank for their support in this.

A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmembers Topper, Tzan, Karpiak and Keedy and Mayor Lincoln. The majority of the votes being affirmative, the resolution was adopted.

Mayor Lincoln showed books donated by the PA American and stated he is hopeful the Carnegie Library will accept the books and create a diversity section for the books.

KEEDY:

Councilman Keedy announced June 1st and 2nd is when the City's audit will begin.

Public Works Report

A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmembers Topper, Tzan, Karpiak and Keedy and Mayor Lincoln. The majority of the votes being affirmative, the resolution was adopted.

Mayor Lincoln praised what City Clerk Ohler has done to clear out the fire hall and the hard work he has done to get the job finished.

Resolution No. 5-18-2021: "To adopt a Standard Operating Procedure that mandates all event organizers complete a "Utilization Form" when requesting permission for an event within the City. Forms must be submitted before approval of such an event."

A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmembers Topper, Tzan, Karpiak and Keedy and Mayor Lincoln. The majority of the votes being affirmative, the resolution was adopted.

TOPPER:

Health/Code Officer Report New Haven Hose Report

Councilman Topper thanked Solicitor Tim Witt, City Clerk Vernon Ohler and Code Officer Tom Currey for all their work on the next resolution. He stated this is an updated sign ordinance due to Supreme Court Rulings which caused municipalities to tweak their Sign Ordinances. Councilman Topper stated the City does not have a lot of say in the Sign Ordinance and explained the layout of the ordinance.

Resolution No. 5-19-2021: "To introduce Bill # 1 of 2021: AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF CONNELLSVILLE, FAYETTE COUNTY, PENNSYLVANIA, This Ordinance shall be known as the Sign Ordinance of the City of Connellsville, Fayette County, Pennsylvania. The purposes of these sign regulations are to encourage the effective use of signs as a means of identification and communication, to maintain and enhance the aesthetic environment of the City of Connellsville, to enhance pedestrian and vehicular safety, and to promote and protect the public health, safety, morals, and the general welfare of the City by avoiding the uncontrolled proliferation of signs."

Mayor Lincoln and City Council discussed some of the issues with signs at the present time.

A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmembers Topper, Tzan, Karpiak and Keedy and Mayor Lincoln. The majority of the votes being affirmative, the resolution was adopted.

Councilman Topper stated the Zoning changes they are working on should be coming out soon. He also stated with grass growing right now, we are looking into ways to enforce keeping grass cut. He noted

that sending a letter to the owner of a property and then waiting is not working so they need to look into other options. He also added they are going to look into blight this summer.

Mayor Lincoln announced LERTA ends in August.

Mayor Lincoln stated June 2nd at 6:30 PM the County is bringing back their Wednesdays Walks. He added this is a fun way to explore the county in the summer. He also added the first one will be in the City at Yough Park where people can see the new visitors center and concession stand. He noted New Haven Hose will be there with their new side by side and General Braddock's Fish Club will be handing out bottles of water.

Resolution No. 5-20-2021: "That this meeting of City Council does hereby adjourn."

A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmembers Topper, Tzan, Karpiak and Keedy and Mayor Lincoln. The majority of the votes being affirmative, the resolution was adopted.
