Old Business:

- Update on City Matters
 - o Mayor Daugherty stated there is property north of 7th street in the county that is not in the city of Duquesne and Duquesne had to run a sewer line on his property. The landowner chose to go with Joplin even though Duquesne paid for the sewer with grant money. Joplin took over the sewer line and Duquesne will have to still pay off the sewer debt. Mayor Daugherty now wants to know how the city wants to proceed with our own sewer billing. Joplin wants to do the billing and Duquesne has gone to some existent to purchase the software to do our own city sewer billing. Mayor Daugherty stated she has requested a couple of times under the "Sunshine Law" for sewer information and Joplin has failed to provide that information. Mayor Daugherty also stated she has requested under the "Sunshine Law" a list of names of residents who are behind or who have not even paid their bill and Joplin has no record of shutting anyone's water of. Mayor Daugherty sent a letter to the Mayor of Joplin asking that they communicate with our software provider. I have received no response. Mayor Daugherty has been told by the water company that Duquesne water belongs to the city and right now we are in agreement with Joplin for them to provide that information. Mike Talley stated there is a possible litigation that can be discussed in closed session.
 - Mayor Daugherty stated Mr. Ward called her over the summer about the odor. Alderman Heilburn has attempted to contact DNR but DNR is slow to respond because they have a large area to cover and by the time they get there the odor is gone. Mr. Ward stated he does not know what else to do.
 - O Alderman Bone stated he has not received Cris Gurubel log sheets and asked Alderman Heilburn to e-mail to him. Mayor Daugherty asked if the log sheets could be e-mailed to her as well. Alderman Heilburn stated he has the logs and will forward them to the other council members. Alderman Welch stated she did not want a copy.
 - Alderman Bone about moving a sign on the NW corner of 25th and Freeport and it has yet to be done. Mayor Daugherty advised she has asked Chris over

the summer to move it. Alderman Heilburn (Street Commissioner) has been advised.

- o Mayor Daugherty advised there is a large hole on Morgan Court that is in need of repair.
- o Mayor Daugherty had complaints that there is poor lighting on some of the street. Chief Kitch will check on it.
- o There have been some complaints of someone on Morgan Court having several rummage sales though out the year. Mike Talley advised the ordinance says a person can have a total of 4 rummage sales a year for 3 days and have to be at least 30 days apart.

• Update on Soft Trail

o Chief Kitch advised 4 out of 10 said yes. Some people had questions as to liability issues and about officers showing up at their door in uniform. Chief Kitch advised people did not feel comfortable so he shut the process down.

• Policy for Surveillance

 Alderman Heilburn advised he has not heard back from anyone on the policy he sent out reference the surveillance. Mayor Daugherty advised it can be discussed at next month's meeting.

- Rick Gamboa, 4005 E.20th,
 - o Wanted to know why the P&Z minutes were not posted on the web site since 06/01/2015 when the web site says they are posted. Mayor Daugherty advised it is a courtesy that the city does by posting the minutes on the web site. The city is not obligated to post them on the city web site.
 - When will the city map be updated because the P& Z has requested an updated map because the one they have to work with is from 2008? Mayor Daugherty stated she would not have the time to update the map and the council can either hire someone, assign an employee to do it, or someone can volunteer to come in and help update the map.
 - Since the city audit is done is it public record and what were the results?
 Mayor Daugherty, Alderman Bone, and Alderman Welch all stated that everything was fine concerning the audit.
 - Who is contracted to do our street cuts? Mayor Daugherty advised that no one put in on the first bid that was sent out. There will be another bid will be sent out in the near future.
