#### Trevor's Column

Dear sisters and brothers,

We have just one more week to make known our views about the proposed NSW Voluntary Assisted Dying Bill to the NSW Upper House Parliamentary Committee. It is imperative in our democratic processes that we communicate our Christian views on the value and sanctity of life regardless of whether it is compromised by disease or disability.

The biblical position is that all human beings are made in the image of God, and that our uniqueness carries with it the responsibility to love our neighbours as ourselves and care for the weak. Human life is a unique gift from God and it is therefore not our prerogative to decide the timing and manner of our exit from this life. As a result of this Christian core value, the taking of any human life has been regarded as a grave matter in our culture and has only been legally countenanced in extreme circumstances.

Although promoted as a so-called answer for intolerable suffering, voluntary assisted euthanasia ignores the positive advances in palliative care which really deserves greater Government investment. Rather than impacting only those who choose this option, the proposed legislation will put unwarranted pressure on the terminally ill or the disabled who may feel they have become a burden to their families. Furthermore, given the current levels of elder abuse in Australia, the frail aged and those with dementia or other such impairments will be particularly vulnerable to potential manipulation.

To facilitate feedback on this, the inquiry has set up an electronic survey at <a href="https://www.surveymonkey.com/r/XRQNHFZ">https://www.surveymonkey.com/r/XRQNHFZ</a>. This includes provision for a short explanation of your reasons. It is crucial for the authenticity of our response that each individual expresses this in their own words. I suggest you take one or two points which are significant to you from the summary referred to below and expand on them clearly and concisely. Remember that you are writing to parliamentarians responsible for the whole of society, so try to use words and arguments that make sense to non-churchgoers.

Two explanatory documents were emailed to all on our contact list on 2nd November 2021 and one of these was included in the printed *Wavelength* last week as a summary of concerns. Please contact me if you would like further copies of these. You can also write an ordinary letter to the <u>Standing Committee on Law and Justice, NSW Parliament, Parliament House, 6 Macquarie Street, Sydney, NSW 2000. It is very important that Christian voices are heard in this debate, so I urge you as citizens of both God's kingdom and of Australia to act on this matter

(Text for 10.30 & 5.30pm Bible message)

Now listen, you rich people, weep and wail because of the misery that is coming on you. <sup>2</sup> Your wealth has rotted, and moths have eaten your clothes. <sup>3</sup> Your gold and silver are corroded. Their corrosion will testify against you and eat your flesh like fire. You have hoarded wealth in the last days. <sup>4</sup> Look! The wages you failed to pay the workers who mowed your fields are crying out against you. The cries of the harvesters have reached the ears of the Lord Almighty. <sup>5</sup> You have lived on earth in luxury and self-indulgence. You have fattened yourselves in the day of slaughter. <sup>6</sup> You have condemned and murdered the innocent one, who was not opposing you.

#### **A SPECIAL MESSAGE ABOUT FINANCES**

# from our Parish Council

At our Annual (Parish) General Meeting earlier this year we, as a Church Family, adopted the budget for 2021 prepared by Parish Council. This budget contained the level of income that was needed from both our centres, Milton and Ulladulla, to meet our expected expenses for the year.

During the course of the year, Parish Council has been increasingly concerned that our **income from offertories** at **both** centres has been **well below** the budgeted figure.

At St Martin's, we needed an income from offertories by the end of October of **\$180,600**. However, as at 31 October offertories received totalled only **\$147,649**. This is **\$32,951** short of the figure that is needed at this point of the year to meet our expenditure commitments.

Now that we have resumed on-site meetings, Parish Council wishes to highlight this significant shortfall to the Church Family at Milton and Ulladulla.

Quite understandably, the interruption to our normal Sunday meetings during the pandemic caused disruption to the 'giving routine' of many folk, especially those who are accustomed to putting cash in the offertory collection each week at a Sunday Service. However, there was **no pause in our expenses** during this time, and **no financial assistance** was available through government subsidies.

Parish Council is very grateful for all those who continued their offertory during the pandemic restrictions, either by electronic transfer or by bringing their cash offertory to the Church Office (sometimes at considerable physical effort). It has been encouraging also that, since on-site meetings resumed, some folk have given offertory envelopes for all the weeks that we were unable to meet.

#### However a significant shortfall in offertories remains.

While a shortfall of income can be met temporarily from cash reserves, it cannot be sustained for very long. Thus, without a **significant improvement** in the income needed to meet our financial commitments (*primarily ministry staff, and property costs*), Parish Council will need to look at how to reduce expenses in the budget for next year.

Parish Council therefore asks **all** members of our Church Family, at Milton and Ulladulla, to make our financial predicament a matter of **urgent** and **prayerful** consideration.
