  - Mark Jensen brought up the construction that will be taking place on Highway Q.

    - Cemeteries- Mark Jensen what about McAuly? Can they do a private burial? Need a final disposition for the McAuly burial. Farmington has an ordinance that prohibits private burials. Caroline Murphy do you want the town board to pursue the McAuly cemetery. If it becomes ours then we could legally sell plots there.
