We currently have a running invoice on the amounts spent to maintain this property since it has been abondoned. The total is at \$370.000 which includes the \$110.00 dues. We will pursue this matter until MPOA has been reimbursed in full for any monies spent.

A) The Board has notified Brazoria County Road & Bridge Dept. that there are quite a few repairs needed throughout the neighborhood to both road and driveways. The cracks are due to the lack of rain and it unfortunately it is happening all over the county. They just happened to repair the street in front of Terry Monroe's house since she was the one who called it in. She can assure each and every resident that she spoke to Road & Bridge the following day after discovering her property had been mended & she requested that the entire neighborhood be repaired wherever it is needed. Mr. Alan Visi, precint 3, assured her they were short handed, experiencing budget cuts and with the county being so big, it's taking them a long time to get all the repairs done. They will handle our repairs just as soon as they can.

B) All of you may have noticed the restrictions on the sale of fireworks this year for the 4th of July. For you & your neighbors safety, if you are planning on having fireworks, please be mindful of the dry conditions and use them with CAUTION should you decide to partake!!!!!! This is also a reminder that cleanup of firework debris both in your driveway and the road is your responsibility. The firework stands are allowed to only sale fireworks from July 1st to 4th.
