Connellsville City Council MINUTES MARCH 19, 2019

This regular meeting of the Connellsville City Council was held this evening at 6:00 PM at City Hall, Connellsville, PA. Attending this meeting was Mayor Lincoln, Council members Keedy, Karpiak, Tzan and Topper. Also attending was City Clerk Ohler and Solicitor Witt.

PLEDGE OF ALLEGIANCE AND MOMENT OF SILENCE:

REMARKS FROM VISITORS/PUBLIC COMMENTS:

Chuck Hubbell, Rotary update, Pennies for Polio

Jamie McPoyle, Youghzilla Race. McPoyle announced those interested can log on to runsignup.com and type Youghzilla in the search to view information on the race which is Saturday, September 28, 2019. He further added this race will promote Connellsville and the Yough Trail. McPoyle noted he is still searching for sponsors.

Nathan Stefano, Eagle Scout Project, Dunbar Troop #180. Stefano would like to help with access to the Crawford Cabin. He presented City Council with a report of exactly what he would do. Stefano stated he discussed his ideas with the Historical Society. He asked City Council to approve his project.

Mayor Lincoln thanked Stefano for taking on this much needed project.

Calli Tony discussed Wellness on the Yough on September 7, 2019 from 11 AM until 4 PM. She stated all proceeds go to the Connellsville Recreation Board. Tony stated Kickstand Kitchen will be the food vendor this year.

Resolution No. 3-1-2019: "To permit Nathan Stefano permission to erect the gate at Yough Park to replace the chain and help with access to the Historical Society."

A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmembers Topper, Tzan, Karpiak and Keedy and Mayor Lincoln. The majority of the votes being affirmative, the resolution was adopted.

CITY TREASURER'S REPORT: Presented by City Treasurer Marilyn Weaver.

Mayor Lincoln questioned Business Licenses turned in.

Weaver answered there are more Business License Registrations this year since notices were mailed out and businesses looked into that have not paid previously.

Councilman Karpiak questioned if Per Capita Taxes were being paid.

Weaver answered that they are and the office has caught people who have not previously paid.

Greater Connellsville Chamber of Commerce, Street closure request

Resolution No. 3-2-2019: "To close South Third Street from 11 PM on August 7, 2019 through midnight August 8, 2019 for the Savor the Avenue Event on Thursday, August 8, 2019; pending review and approval of Police Chief and Fire Chief."

A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmembers Topper, Tzan, Karpiak and Keedy and Mayor Lincoln. The majority of the votes being affirmative, the resolution was adopted.

Amy Price, Community Center Board Request

Resolution No. 3-3-2019: "To appoint Amy Price to the Community Center Board effective immediately; term to expire the first Monday in January 2023."

A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmembers Topper, Tzan, Karpiak and Keedy and Mayor Lincoln. The majority of the votes being affirmative, the resolution was adopted.

Misty Huffine, Community Center Board Request

Resolution No. 3-4-2019: "To appoint Misty Huffine to the Community Center Board effective immediately; term to expire the first Monday in January 2022."

A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmembers Topper, Tzan, Karpiak and Keedy and Mayor Lincoln. The majority of the votes being affirmative, the resolution was adopted.

New Haven Hose Flag request

Resolution No. 3-5-2019: "To sign a contract with New Haven Hose Company Volunteer Fire Department for two 50-star large American Flags, mounted on a pole and displayed in front of City Hall and in front of the Police Department on ten holidays. Total cost for the contract will be \$80.00; money to be taken from line item #489.546, Miscellaneous Contingency."

Mayor Lincoln reminded businesses that sign this contract that it is time to send in your money for the flags.

A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmembers Topper, Tzan, Karpiak and Keedy and Mayor Lincoln. The majority of the votes being affirmative, the resolution was adopted.

REGULAR AGENDA:

Resolution No. 3-6-2019: "To approve the minutes from the February 19, 2019 City Council Meeting."

A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmembers Topper, Tzan, Karpiak and Keedy and Mayor Lincoln. The majority of the votes being affirmative, the resolution was adopted.

Resolution No. 3-7-2019: "To waive the Four-Day Resolution Rule to allow for items submitted after the Four-Day Rule to be read at the meeting tonight, such Resolutions will be marked with an asterisk."

A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmembers Topper, Tzan, Karpiak and Keedy and Mayor Lincoln. The majority of the votes being affirmative, the resolution was adopted.

MAYOR LINCOLN:

Mayor Lincoln stated he is going to read a statement and the City was served "papers" today from the Connellsville Community Center Board. He added that City Council will not comment individually until the City Solicitor gives them the "A-OK".

The statement was read as follows: "The City is thoroughly reviewing the allegations made in the complaint. On it's initial review the City believes the allegations were grossly mischaracterized the facts in the situation relating to the City's actions to protect the Community Center and interests of the public. The City intends to fully defend against these allegations and finds that it is unfortunate that the persons claiming to support our community would now seek to attack it at a cost to the tax payers. As it deals with matters in litigation, the City cannot provide any further comment at this time."

Police Department Report

Chief Hammerle answered Mayor Lincoln concerning the Eighth Street accident and stated when the weather breaks, they will be able to paint new lines to clock speeders.

Mayor Lincoln stressed that it is time for the State to allow radar to be used to catch speeders. He also added he is hopeful PennDOT will put the guiderail in around the corner for safety.

Mayor Lincoln then discussed the County giving the City a K9 Unit vehicle.

Chief Hammerle stated the biggest cost for the K9 Unit is the upstart and vehicle. He added the County and DA's Office is permitting the Police Department to use their 2009 Dodge Charger which is a Police Package Vehicle. Hammerle added it would be marked as a Connellsville Police car and fitting with the dog insert. He further noted it would be maintained by the County and they will carry the insurance so it does not cost the City money. Hammerle stated "In turn we would make our K9 Officer available to other municipalities in Fayette County that needed a dog." He added his wages would be paid for by the County Investigative Office.

Mayor Lincoln questioned how the fundraising for the K9 Unit is going.

Chief Hammerle stated the fundraising is fantastic. He added a lot of businesses and residents have mailed in checks for the K9 Unit. Hammerle added after they receive the vehicle, they will purchase the dog and get it trained.

Resolution No. 3-8-2019: "To permit Mayor Greg Lincoln permission to sign any and all PennDOT documents pertaining to the completion of the mural under Memorial Bridge."

A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmembers Topper, Tzan, Karpiak and Keedy and Mayor Lincoln. The majority of the votes being affirmative, the resolution was adopted.

Resolution No. 3-9-2019: "To accept the donation of a certain 2009 Dodge Charger with a Police Package from Fayette County for the City of Connellsville Police Department K9 Unit. All costs related to this vehicle will be absorbed by the County."

Mayor Lincoln thanked District Attorney Richard Bower, noting he has gone above and beyond for the City. He further added he appreciates all of his support.

A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmembers Topper, Tzan, Karpiak and Keedy and Mayor Lincoln. The majority of the votes being affirmative, the resolution was adopted.

KARPIAK:

Public Works Report

Councilman Karpiak announced the lot by the City Garage is being cleared and almost ready for the groundbreaking of the new cell tower.

Resolution No. 3-11-2019: "To approve City Mission - Living Stones, Inc. Overhead Banner Request, as submitted. Overhead banner is to be erected on West Crawford Avenue and Third Street from April 8, 2019 and removed May 8, 2019."
