Connellsville City Council MINUTES April 20, 2021

This meeting of the Connellsville City Council was held this evening at 6:00 PM. Attending this meeting was Mayor Lincoln, Council members Keedy, Karpiak, Tzan and Topper. Also attending was City Clerk Ohler and Solicitor Witt.

PLEDGE OF ALLEGIANCE AND MOMENT OF SILENCE: Pastor Don Smith led invocation.

REMARKS FROM VISITORS/PUBLIC COMMENTS:

Mike Allison from As They Come Rescue proposed a Rescue Event at Woodruff Dog Park. He suggested a table with information on the organization, fostering and applications to adopt a pet be set up. Mr. Allison stated all the animals have been to the vet and ready for adoption. He also discussed selling items and basket raffles along with a dunk tank and corn hole games.

Mayor Lincoln stated the possible opening of Woodruff Park may be May 22nd. He added he wants to be sure that date works for the Chief of Police and K9 Officer. Mayor Lincoln stated he should know in the next few days and will let him know.

Dr. Frank Jacobyansky, Recreation Board President, discussed the April 24th City-wide clean-up. He announced there are between 70 to 100 volunteers that are mostly school groups. He requested that anyone who spots an area that needs cleaned up to please let him know.

He also stated there were no events this year, therefore there is no money this year. He added they usually spend the money to upgrade the parks so they will depend on fundraisers this year which "we are planning on doing". He announced big events coming up: The River Rally which profits are being split between the Recreation Board and Braddock's Fish Club, there is Wellness on the Yough and Tangled Up In Brew. He added there is summer basket ball program in the parks. He also stated the Recreation Board would like to possibly do movies in the park this summer and a scaled down recreation program.

Mayor Lincoln stated for the clean-up, all the parks have been cleaned in the past as well as the 119 corridor and York Avenue at the Amtrak Station.

Dr. Jacobyansky stated they will not be doing 119 this year due to his not being able to coordinate traffic control.

Pastor Don Smith discussed the National Day of Prayer being the first Thursday in May, which is the 6th from 12 noon to 1 PM at Veteran's Plaza. He added the Adopt a Block is the 3rd Saturday in July, which is the 17th from 1 PM until 8 PM.

Rita Smith, Fayette County Crime Victims, Sexual Assault Awareness Month.

Judge Ron Haggerty, Informed City Council that through his office he has been using Community Service workers to clean up the City in lieu of fine money.

Judge Haggerty discussed the Yough River Rally and wanted to be sure there was nothing else they needed from the City for the event. He notified Council they are waiting for quotes for the insurance for the park. He added the response has been great and everything is moving well with the planning. He also stated the tickets for the ducks will be sold at the concession stand on weekends and there are 2,000 ducks with a 50/50 payout. He also said all local foods will be sold, including pizza out of the concession stand.

Councilwoman Tzan read the following resolution:

Resolution No. 4-16-2021: "To grant permission to General Braddock's Fish Club to hold the Yough River Rally on June 4th, 5th and 6th, 2021, at Yough Park, in conjunction with the Connellsville Recreation Board. General Liability Insurance must be provided with the signed agreement."

A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmembers Topper, Tzan, Karpiak and Keedy and Mayor Lincoln. The majority of the votes being affirmative, the resolution was adopted.

Mayor Lincoln wish City Treasurer Weaver a happy birthday.

CITY TREASURER'S REPORT:

Treasurer Weaver stated her office is short on collections of about 80 business registrations. She added she believes some of those businesses have closed but will mail out reminders to pay by the end of April and after that there will be a \$20 fee.

MAYOR LINCOLN:

Police Department Report and informed City Council of the update training they receive.

Mayor Lincoln stated South Connellsville Borough had their meeting this month and are discussing having the City police take over their police protection 24/7.

Chief Hammerle noted the last Civil Service Test he put out expired and another test will be put out. He noted this is to "build" the list at this time.

Resolution No. 4-3-2021: "To donate \$80 to New Haven Hose Volunteer Fire Department for two American Flags to be displayed at City Hall on eight holidays. Money to be taken from line item 409.266."

A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmembers Topper, Tzan, Karpiak and Keedy and Mayor Lincoln. The majority of the votes being affirmative, the resolution was adopted.

Resolution No. 4-4-2021: "To appoint Ethan Keedy to the Connellsville Housing Authority, Term to expire January 2024."

A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmembers Topper, Tzan, Karpiak and Keedy and Mayor Lincoln. The majority of the votes being affirmative, the resolution was adopted.

Resolution No. 4-5-2021: "To approve and enter into a joint paving project intermunicipal cooperation agreement with Connellsville Township and the Connellsville Area School District; and to authorize and direct the Mayor and City Clerk to take such action as may be necessary to execute and effectuate such agreement."

Resolution No. 4-6-2021: "To appoint Kara Addis to the Connellsville Zoning Hearing Board; term to expire January 2022."

A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmembers Topper, Tzan, Karpiak and Keedy and Mayor Lincoln. The majority of the votes being affirmative, the resolution was adopted.

Resolution No. 4-7-2021: "To grant the Chief of Police permission to conduct testing to update the eligibility list of possible new hires if needed."

A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmembers Topper, Tzan, Karpiak and Keedy and Mayor Lincoln. The majority of the votes being affirmative, the resolution was adopted.

Youth Art judging of flags by City Council:

Mayor Lincoln stated City Council was approached by Dan Cocks from Downtown Connellsville and the Fayette County Cultural Trust to judge Yough Art Month Contest from Springfield Elementary. He added first place is a \$75 gift certificate to Appalachian Creativity Center and the runner up will receive a \$25 gift card to Atkin's Music. Mayor Lincoln thanked Downtown Connellsville and the Fayette County Cultural Trust for hosting this contest and thanked the students for the entries.

Mayor Lincoln then announced the winners: 1st place was submitted by Taylor Knopsnider and runner up is Jason Fletcher.

Mayor Lincoln discussed the City's first Diversity Inclusion Board Meeting with Melinda Powell from Mid Penn Bank who created a Diversity Inclusion Council. He added they are sponsoring a Juneteenth

Writing Contest. He further added the deadline is May 21st and there will be two winners from each branch announced June 10, 2021. Mayor Lincoln read information on this contest. He added there may be a program on June 19th at Veteran's Plaza at maybe 1 PM for an hour-long program. Mayor Lincoln stated he will bring it before Council in May.

KEEDY:

Resolution No. 4-8-2021: "To approve the eligible list of active volunteers as submitted to the City of Connellsville, for tax credits under Act 172 and Ordinance #1533 of 2018 by "qualified Participants" Fire Chief."

A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmembers Topper, Tzan, Karpiak and Keedy and Mayor Lincoln. The majority of the votes being affirmative, the resolution was adopted.

Councilman Keedy stated the Quarterly Budget Meeting was held last week and they are 3% over what they were last year. He noted that some of the expenditures are going to be reimbursed later in the year therefore possibly being where things were last year.

Mayor Lincoln announced that City Hall will be open May 10th with masks required. He added by then, the employees will all have been vaccinated.

KARPIAK:

Public Works Report

Resolution No. 4-9-2021: "To Place Out for Bids the 2021 Paving Project, all bids must be submitted by May 12, 2021 at 4:00 PM to Widmer Engineering and will be open on May 12, 2021 at 6 PM at Connellsville City Hall, 110 North Arch Street, Connellsville, PA 15425."

A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmembers Topper, Tzan, Karpiak and Keedy and Mayor Lincoln. The majority of the votes being affirmative, the resolution was adopted.

TZAN:

Resolution No. 4-10-2021: "To accept the bid of Navaeh in the amount of \$71,037.00 for the re-roofing of the Connellsville Public Works Garage; pending review and approval of City Solicitor and City Clerk."

A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmembers Topper, Tzan, Karpiak and Keedy and Mayor Lincoln. The majority of the votes being affirmative, the resolution was adopted.

Resolution No. 4-11-2021: "To hire Chase Bodenheimer as a summer worker for the Public Works Department at a rate of \$8 per hour for a maximum of 35 hours per week for the summer season, such cost to be taken from line item #01430-145."

A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmembers Topper, Tzan, Karpiak and Keedy and Mayor Lincoln. The majority of the votes being affirmative, the resolution was adopted.

Mayor Lincoln suggested raising the from \$8 to a higher rate.

Resolution No. 4-12-2021: "To purchase two planters from the Greater Connellsville Chamber of Commerce for the front of City Hall at a cost of \$35 each, money to be taken from line item 409.266."

A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmembers Topper, Tzan, Karpiak and Keedy and Mayor Lincoln. The majority of the votes being affirmative, the resolution was adopted.

Resolution No. 4-13-2021: "The City of Connellsville declares its intent to follow the schedules and procedures for disposition of records as set forth in the Municipal Records Manual adopted December 16, 2008 and amended on March 28, 2016."

Mayor Lincoln explained this is for the records that have been stored at the Fire Station to be moved. He added the Redevelopment Authority will be putting bids out next month on the building.

City Clerk Ohler stated this resolution allows us to dispose of the boxes and the next resolution states what is being disposed.

A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmembers Topper, Tzan, Karpiak and Keedy and Mayor Lincoln. The majority of the votes being affirmative, the resolution was adopted.

Mayor Lincoln thanked Vernon Ohler for his hard work at the Fire Station and noted Council discussed a bonus to him for the extra work he has been doing going through the boxes.

Councilwoman Tzan announced that Representative Warner will host a Shred It Event at the high school on June 12th from 10 AM – 2 PM. She added this is for anyone but businesses.

TOPPER:

Health/Code Officer Report

Councilman Topper reminded residents to keep their grass cut.

Councilman Topper discussed last night at the Redevelopment Authority a bid was awarded to demolish a property on East Crawford Avenue in the Madison and Murphy area. He added this structure burned a couple years ago. He also added the owner had a building permit that was good for two years and the City couldn't do anything legally until that building permit expired. Councilman Topper stated they can now have it torn down.

Mayor Lincoln asked Code Officer Currey for an update on the three properties on Fairview Avenue.

Code Officer Tom Currey stated there is no change yet and he is waiting for the property owner of the primary house to respond back to the City and say what their plans are going to be.

Mayor Lincoln asked if there is any concern of the homes collapsing before they respond.

Code Officer Currey replied yes as one house is resting on the other house. He clarified the properties are vacant at this point. Currey stated a letter was sent Certified to her from the engineering company who said it was a dangerous structure and needs to come down. He added when the green card comes back – as proof the owner received the Certified Letter – he will contact the owner and ask what the plan is.

Mayor Lincoln asked what the time frame is to give them before the City does something.

Code Officer Currey stated there is no time frame yet. He added that it is on the City's front burners and the owner has to get contractors involved.

Mayor Lincoln asked if there is concern for safety of the travelers on the street.

Code Officer Currey answered that it will not fall into the street and what happened is the property shifted and is resting on the property to the right of it. He added it will fall away from the street and noted there may be some blow back.

Councilman Topper updated the Sign Ordinance being written and taken before the Planning Commission. He added there is a procedure that needs to take place before it goes before City Council. He stated it is now being reviewed by the County and he hopes to have it at the next Council Meeting.

New Haven Hose Report by Lieutenant Addis

Lieutenant Addis reminded residents and City Council about the 5K Neon Nights Race on May 8^{th} . He added when you come and register, you will get a bag with goodies. He added May 7^{th} from 5 PM -8 PM at the station is pre pick up. He noted the day of the race you can register from 5 PM until 7:30 PM. Addis stated it is \$20 until the 23^{rd} and \$5 more after that.

Lieutenant Addis stated they now have their "side by side" and now need a trailer to haul it. He added they need to raise \$1,500 for it.

Mayor Lincoln asked residents wishing to donate to mail checks to: 123 S 7th Street to New Haven Hose.

Councilwoman Tzan notified everyone there is a ballot question "should the State expand its low interest loan program for VFD and EMS companies.

Resolution No. 4-19-2021: "That this meeting of City Council does hereby adjourn."
