

#### Voices of older people on the pandemic

Throughout the first lockdown of the COVID-19 pandemic, in the Spring of 2020, Age NI listened to older people talking about their experiences, their concerns and fears as well as their hopes for a safer future. We captured people's views and voices in a short report called *Lived Experience* – *Voices of older people on the COVID-19 pandemic 2020*. There were four key themes:

- Support, health and care
- Communication and connection
- Loneliness and isolation
- Grief and loss

Age NI in 2020 set out a series of actions urging decision-makers to plan and prepare for life after the pandemic and to learn from older people's shared experiences.
