

## CLERK'S GENERAL REPORT FROM 28<sup>TH</sup> OCTOBER 2020 TO 24<sup>TH</sup> NOVEMBER 2020.

### Finance/Administration.

### Three Parishes Meeting.

### Planning Matters.

Application 20/01767/HH: Two-storey rear extension and first-floor side extension with parking undercroft, 461 Rickstones Road dealt with between meetings with 'No comments' forwarded to BDC.

### Land South West of Rivenhall Oaks Golf Course.

A screening opinion has been issued by BDC - we await the inevitable outline planning application.

### General Highway Maintenance.

During w/c 8<sup>th</sup> November any number of HGVs had been driven towards the railway bridge on Oak Road and in one particular incident a streetlight and gate entrance were demolished. The incident was witnessed by a member of the public who notified myself, and ECC Highways, it was also witnessed by at least 2 Ringway Jacobs operatives who were working in that area.

The Chairman has written to ECC Highways complaining of the damage caused by HGV drivers trying to avoid the A12 closures by using local country roads.

Little Braxted Lane is closed to vehicles, possibly for up to 5 weeks, subsequent to the damage to the bridge done by an HGV being driven in disregard to the prohibition signs.
