

Last month, Melinda and I accompanied Carter on his college visit to lowa State. For one of the sessions we visited the Chemistry building and talked with two of the professors and toured the classrooms and labs. During the tour, one of the professors mentioned the field of Quantum Mechanics and the research they were doing in that field. This immediately peaked my interest because I have a personal interest in that field and have used it in a couple of sermons. Maybe you remember my sermons on light and creation (if not you can go to the YouTube Channel). Following the tour they asked if there were any questions, not wanting to take away time from any potential students I waited until the end.

In talking with the professor, she asked where I was coming from in my interest in Quantum Mechanics. I told her I am a pastor and used it in my sermons and in developing my personal understanding of the creation of the universe and the miraculous in the bible. In particular how we understand light – light is the only known substance that acts as both a particle and a wave. Every other substance is either one or the other – not both. She told me she is a Christian and when teaching this to students she tells them that we do not know why light behaves this way, "we have to take it by faith." We talked for quite awhile and then I was informed that it was lunch time and Melinda and Carter were hungry. At lowa State there is a class titled Science and the Bible which is taught by two other professors who are Christians. Most of the students who take the class are not Christians but are curious about how science backs up the bible and the bible supports what we know through science.

A fear parents have when they send their children off to college is that they will fall away from their faith. This is a legitimate fear as some institutions have become indoctrination centers but I have been encouraged by Hannah, other students, professors, and clubs that proclaim the light of the Gospel and encourage students to live it out. College is a wonderful opportunity to meet new people, gain valuable experience, learn and grow while expanding your surroundings. Faith is more than just a belief; faith grows when it is challenged and questioned and college does that – in a good way. Keep our college students in prayer and those who are getting ready to head off to college for the first time this fall.





Dear Inspiration Readers,

When I was a seminary student studying theology there was a senseless joke going around in our classes based on Jesus asking his disciples "Who do people say I am?" (Mark 27-29). They replied, "You are the eschatological manifestation of the ground of our being, the kerygma of which we find the ultimate meaning in our interpersonal relationships". And Jesus said, "What!" Please don't go to Webster's Dictionary. Personally, I like Peter's straightforward answer: "Peter answered, "You are the Christ." However, I was challenged recently with a response to a statement by our first black woman bishop of Iowa, Kennetha J. Bigham Tsai, regarding who Jesus is. Her statement may have seemed to some disrespectful of Jesus' Lordship, if not blasphemous. Still, I would like to offer my feedback to our Bishop's statement, but before I do let me apologize to anyone reading my opinion that I may be trying to mansplain what the Bishop said. The words of the Bishop's are her own. Allow me, then, to take another look at what was said. According to the report in the March Church Newsletter. Bishop Kennetha was reported to have said, she did not believe everyone should agree on who Jesus is. Also, that Jesus became incarnate, but not in any particular flesh, not in any particular culture. Also, I want to thank Pastor Rob's take on her statement. His response is familiar and perhaps when you read it you can identify with it. He wrote, "This goes against what might be the traditional understanding that Jesus was a Jewish male in 1st century Israel and downplays his humanity".

So, on the wall of my study hangs the iconic framed picture of Warner E. Sallman's, 1940 painting of the head of Christ. Sallman painted a Northern European Nordic Jesus as a sandy blond haired, blue eyed and light skinned flesh. If you were to ask me to close my eyes and see Jesus this is the Jesus I would conceptualize. For some, in fact, this is what the real Jesus looks like, though, we have no original picture of the Savior. On an adjoining wall I have Eastern Orthodox paintings. When I traveled in the former Soviet Union visiting Orthodox churches Jesus was depicted as a somber orthodox patriarch. When I worked on the Meskwaki Settlement in Tama Iowa there hung in the church a painting of a Meskwaki Jesus on the cross. And in New Mexico at the Navajo Indian School where I assisted in leading an adult work camp from Iowa, Jesus was a Navajo. When I lived and worked on the East coast in Jersey and Harlem a Black or Puerto Rican Jesus was a common depiction. In China Town in New York City, Jesus is Chinese.

A portrait of a "Laughing Jesus" was popular when I was in college. In Australia there is an Aboriginal Jesus and in New Zealand there is Maori "Jesus" with moko, i.e. traditional face tattoos. What these different depictions of Christ tell us is that there is no monolithic vision of Jesus' embodied flesh and the understanding that his very incarnation the fact that God became a human being in itself — is a way of identifying with all peoples everywhere. Art helps Christians to simply relate better to a savior who looks like them. And, perhaps more than the many cultural depictions of Christ, it's our life experiences that determine how we choose to view Jesus. For instance, Dakota Sioux might see in Sallman's sandy brown, long hair, light skinned Jesus a contradiction to the real Savior i.e. the image of another person nicknamed "Long Hair or Golden Hair viz. Gen. George Armstrong Custer who built a reputation on his mistreatment of Native Americans. In fact Vine Deloria suggests such a characterization in the title to his book "Custer Died for your Sins".

In a few days Christians will celebrate Easter Sunday. We confess Jesus crucified dead and buried and on the third day arose from the grave. Forty days after Easter the Christian Church celebrates Ascension Sunday. The "Ascension" marks the moment Jesus literally ascended and was taken up to heaven before his disciples, at the village of Bethany, near Jerusalem. This is significant as it shows that he has returned to Heaven after completing his mission on Earth. That is he was liberated from all earthly limitations of the flesh and his Spirit could work mightily anywhere. In other words Jesus' Spirit is no longer confined to a body of an itinerant light skinned Jewish rabbi in 1st century Palestine. Jesus transcends place, time, and culture. The ascension is not the story of Jesus the Christ going away, but rather being present and seen and heard by each of us as a matter of faith at any time in any place depicted in many types of human flesh.

Ultimately the ethnicity of Jesus' flesh is somewhat irrelevant. What matters is that people find meaning in his life and as Christians that he died on the cross for the redemption of our sins. What a great God we have! Jesus lives, "He's in the world today. Salvation to impart. You ask me how I know He lives? (by Scripture, Tradition, Reason and Experience) He lives within my heart."

Wayne made the motion, with Brad second, to have a congregational meeting where members have a chance to discuss, ask questions, speak, and vote whether to have the Ad Co move forward in the process to leave the UMC. Speakers will have a speaking time limit. A straw vote will be done with every professing/official member being able to vote. Membership list will be used to give out ballots and voting must be done in person. Voting can be done Apr. 23 or 30 after church in person. Ballots may not be taken out of the church. Motion was passed with 8 Yea, 0 Nay. Meeting and vote will be announced in church, in the Newsletter, website, Facebook, and a slide during the church service.

Parsonage. A special meeting of the City Council was held on 3/9/23. They voted to approve that we can rent the parsonage with a limit of 2 residents per bedroom. Richard Schwarm has drawn up \$150/month with minimum rent \$1,000/month for 9 months; 3 months will be \$450/month with no residents. Renters pay for utilities, water, gas, electricity, and tenant insurance. No smoking or pets. The updated financials were presented at the last meeting. Brad moved, with Joyce as second, to approve the Trustees sign the contract with the Casino for 1 year and coming back in 2024 to revisit the situation. Motion was passed with 7 Yea, 0 Nay, and 1 abstaining.

The next meeting will be April 6, 2023, 5:30, to finalize the congregational meeting. The meeting was adjourned at 6:55 am with motion from Brad, second by Dave Imler.

Straw Poll Vote Regarding Disaffiliation - Northwood United Methodist Church

The Northwood United Methodist Church has been in a discernment process for the past few months regarding disaffiliation from the United Methodist Church. Informational packets were made available to congregants as of January. Information has been published in the church newsletter. Three joint meetings were held in February with the Asbury Methodist Church, Lake Mills. Those meetings included viewing videos by Reverend Adam Hamilton and Reverend Rob Renfroe presenting material for and against disaffiliation. Each church held a separate meeting in early March. At the March meetings, Pastor Rob presented possible options for other church affiliations if we moved forward with disaffiliation. All meetings included a time for discussion.

The Northwood United Methodist Church Council has decided to conduct a straw poll to determine whether or not members would like to move forward with a church conference. The church conference would be conducted by the District Superintendent with a specific purpose of voting on disaffiliation. A 2/3 majority of attending professing members would be required to move forward with the disaffiliation process. If the straw poll indicates that a 2/3 majority vote would probably not occur at a church conference, no further steps will be taken and the church will remain with the United Methodist denomination.

The Northwood United Methodist straw poll will be conducted on Sunday, April 16, immediately following the church service. It will be by written ballot. Only professing members can vote. A professing member is defined as having been confirmed in the Northwood United Methodist Church and maintained their membership there or having officially transferred their membership to the Northwood United Methodist Church from another church. If unable to attend the church service on April 16, a member may pick up a ballot in the church office from Monday, April 10 through Friday, April 16, during office hours. Office hours are 11:00 AM - 2:30 PM. The ballot must be returned during office hours that week or returned to the church by the end of the worship service on Sunday, 4/16. If you a have a question about whether or not you are a professing member, Ona VanHeiden, Administrative Assistant, can provide that information during the office hours.

This is an important process as Pastor Rob and the Church Council will determine next steps based on the outcome of the straw poll. We encourage your participation.


