Old Business: Alderman Bone asked about resealing city lot that was added to agenda at Special meeting. He asked about reason matter could not wait for regular meeting. Mayor explained it was inadvertently omitted from agenda. He asked about bids being opened during meeting. Attorney explained it was customary to have bid opening prior to meeting and results presented at meeting for approval.

Utility Road Cut Repair: Clerk said notice of bid request would be advertised in time for October meeting consideration.

Update on City Matters: David Weaver updated Board on attempts to acquire funding for street resurfacing. For CDBG funding, City needs to take income survey to see if City can qualify. City survey boundaries is Range Line east to Duenweg and 7<sup>th</sup> Street south to I-44. Addresses will be submitted for random selection. Fifty-one percent of those surveyed must be in low to moderate income levels and 80% of all surveyed must responded or additional addresses will be needed.

Van Winkle Water Line: Allgeier Martin scheduled to advertise project in October and bid summary should be available for November meeting.

Public Comment: none.

New Business: Police Department Monthly Report: Chief gave report. VHF radio for 813 is not functioning. Radar unit for 814 needed replaced. No action taken on equipment. Chief requested sick leave be changed from four 8-hour days to number of hours officer normally works. Most officers rarely use sick time; but when used, officers work 10 or 12-hour shifts. Motion made by Dale Daniels, seconded by Lisa Daugherty, to approve recommendation. Ayes: Aldermen Daniels, Herron, Daugherty, Bone. Nays: none. Motion carried. Chief has scheduled vacation from October 23 through 28.

Bill Summary: August outstanding bills of \$19,431.01; and \$457.49 for Sewer and Wastewater Fund were presented. Motion made by Dale Daniels, seconded by Frank Herron, to pay outstanding bills. Ayes: Aldermen Daniels, Herron, Daugherty, Bone. Nays: none. Motion carried.

FEMA Storm Shelters: City of Joplin is in charge of disposal of shelters for FEMA. Cities and non-profit organizations were given first chance at free 10'x20' shelters. Each entity would be responsible for cost to move and setup shelters. Cost to move estimated at \$9,000. Board asked audience's opinion. Several residence spoke and all were in favor of City acquiring one shelter. Motion made by Frank Herron, seconded by Dale Daniels, to approve acquisition of one shelter. Ayes: Aldermen Daniels, Herron, Bone. Nays: none. Abstain: Alderman Daugherty. Motion carried. Clerk will notify City of Joplin.

Budget Summary: There were questions about extraordinary revenues and expenses. David gave explanation of past items listed in sections.

Special Budget meeting was scheduled for 7:00 p.m. on Monday, September 23. Lisa asked for information on overtime for meeting.

As there was no further business, motion was made by Dale Daniels, seconded by Roger Bone, to adjourn meeting. Ayes: Aldermen Daniels, Herron, Daugherty, Bone. Nays: none. Motion carried. At 9:00 p.m. meeting adjourned.
