Officer Russell presented correspondence with Chris Johnson, legal counsel for KLC concerning KRS 413.072 on how/when/why the use of property may be exempted from city nuisance ordinances if used for agricultural purpose as it pertains to Odell Martin's lot at Martin Rd/Lynn's Dr. Mr. Martin has made claim this lot is for agricultural purposes and the City cannot enforce it nuisance ordinance.

Upon consideration of the Board, Officer Russell was instructed to inform Mr. Martin there is insufficient evidence of the property being used for agricultural purpose, specifically hay production and the ordinance should be further enforced.

Another lot owned by Mr. Martin bordered by Hart and Fairview Ave was also discussed which has a large amount of thistles. The Board instructed Russell to inform Mr. Martin this lot is in violation of both city and state ordinance pertaining to thistles.
