

A Public Hearing on the Preliminary Budget for 2021 for the Town of Addison was held on Monday, November 2, 2020 at 6:00pm at 21 Main St. The following people were present:

Supervisor Miller called the meeting to order at 6:01pm asking all to stand for the Pledge of Allegiance.

Supervisor Miller stated he had sought council with the Town Attorney because the Budget Officer hadn't received an estimate from the Highway Superintendent per Town Law 104. Attorney recommended that Supervisor Miller look at the Town Roads and determine the work needing done and provide estimate as required. Supervisor Miller provided the following estimates totaling \$54,000:

Motion by Supervisor Miller, seconded by Councilperson Lyons to go into the Public Hearing on the 2021 Preliminary Budget at 6:10pm.

Supervisor Miller asked board if there were any changes that need to be done to the presented budget for 2021. It was noted as long as its what was presented then no changes are needed. Councilman Conklin noted his objection to line item DB5110.1.

Motion by Councilman Thompson, seconded by Supervisor Miller to adopt Preliminary budget as presented. Town Clerk - \$16,200.00; Superintendent of Highway - \$51,000.00; Town Justice - \$9,000.00; Supervisor - \$3,600.00 Councilmen - 4 each \$1,200. Total to be raised by taxes 432,090.51 which is a .524% increase. Roll call was taken and motion did pass. David Miller - yes; Jack Thompson – yes; Brandon Conklin – no; Alice Weale - yes; and John Lyons - yes.

Motion by Councilperson Thompson, seconded by Supervisor Miller to go out of Public Hearing and back into regular meeting at 6:26pm.
