

Who is a medical professional?

Someone who is involved in your care and treatment, E.G. your GP, nurse or consultant. They will be asked to support your application and if you meet the criteria. This cannot be your carer. All information received is treated in the strictest of confidence.

Are there any limits as to what wedding we can have? We will meet with you to discuss your application should you be shortlisted. At this meeting we will talk in depth about the kind of wedding you would like, how many guests etc. It will be then that we decide if we have enough funds and suppliers in your area to carry out your wishes. The more extravagant the wedding the less like it is that we will be able to. However we can put on a more than substantial wedding for our applicants.

What sort of things would you like to see from my application? We want to get to know you, this isn't always possible from a written application. So we want to see photographs, videos, letters, poems, anything that you think will show us why it is so important that you marry each other, what your home life is like, how hard it is living with your illness. Please grab our attention with your applications.

I've sent my application now what? We aim to look at your application within a week of receiving it. We will then discuss with the board of Trustee's your application, how and if we think we can help you. If we think we can we will then meet you to go over your wedding expectations. If after that we feel we can help we will commit to your wedding. If we cannot meet your expectations we will contact you. If you wish to reapply then you can do after 1 month has passed form the date on your rejection correspondence.

What happens if I am too ill to go ahead with the wedding? If the wedding is growing closer and it is looking unlikely that you will be able to go ahead. We ask you to let us know in writing as soon as possible so that we can cancel all our suppliers. If this hap-pens and you would like to try again at a later date then contact us to discuss this. Again in the event of death please contact us before the wedding date.

Who meets the cost of our wedding? * The Wedding Wishing Well will try to fund all or part of your wedding, however you will know how much is covered from the beginning. We meet the cost by dealing with suppliers who work with us providing very generous discounts or their services for free. For the remainder of the costs we have fundraising teams who work tirelessly to keep the funds coming in.

Damages or expenses due to theft during the Wedding will be charged to the bride & groom.

*Please note that we DO NOT cover the cost of the marriage (i.e. marriage license, church fees, registrars fees etc.)

What if it rains? As much as we try and make your wedding day perfect, unfortunately the weather is out of our control. We will try and still make it as special as possible whatever the weather.

What happens on the day? On the day where possible a wedding planner will be with you to make sure that any problems are ironed out.

Problems? Occasionally problems can arise, as we are working with 3rd parties, which are out of our control. But by having a wedding planner present these can be kept to a minimum so that your wedding goes very smoothly. Sometimes things do happen which are out of our control. Please rest assured that those working on your wedding will do their best to make sure this does not happen.

What can I ask for? You can ask for anything you like. We do our best to be able to get you the things that you have always dreamed of for your wedding. We cannot promise that everything will be possible but we do our best to make your day extra special.

Do you offer cash grants to get married? No we do not offer sums of money to couples to get married nor cover the cost of suppliers (including venues) arranged by the couple prior to acceptance. All other suppliers need to be discussed with the team before approaching, as we will negotiate on your behalf.

What's the catch? There is none! We are hear to make sure that no matter what your health situation is that you have the wedding day you've always dreamed of.

Terms & Condition of this application

The Wedding Wishing Well Foundation supports applications for same sex marriages; divorcees but we do not condone applications from incestuous relationships, as this is illegal.

We also do not discriminate against religions or race.

The Wedding Wishing Well Foundation may not be able to cover the whole cost of your wedding but we will discuss this with you after we receive your application.

We will try to fund all or part of your wedding, however we will help with the organising of your special day.

We cannot also fulfill the wishes of every single application we receive. We will meet with the board of Trustee's who will discuss a number of applicants and decide who we can help with the team, budget and suppliers we have.

Any expenses incurred due to damages or theft will be the responsibility of the bride & groom without acceptation.

Should you feel that the wedding needs to be cancelled due to illness or death then please let us know as soon as possible so that we can let our suppliers know.

To apply for help from The Wedding Wishing Well Foundation you must meet the following criteria:

- I am free to marry
- I am in receipt of a means tested benefit
- I live in mainland England or Wales.
