### ACA ACCREDITED

Camp Trusted Parents is ACA Accredited!

American Camping Association (ACA): ACA is an organization with members in all 50 states that accredits all types of organized camps. Camps are accredited based on the administration, policies, and camp operation; particularly those related to program practices and quality along with health and safety of campers and staff. The standards establish guidelines for needed policies, procedures, and practices. Our camp is fully accredited with a score of 100% on last summer's audit. We are committed to providing the highest standards established for the camping industry.

### OUR STAFF

Camp Trusted Parents Program Director supervises the entire camp operation. Our camp counselors are hired for their leadership abilities and will assist the Program Director in camp operations. They are teachers, professional therapist, college students, and others at least 17 years of age who were selected through an intense interviewing process. Pre-camp staff training emphasizes the important camping issues such as camp safety procedures, staff development, setting the culture of inclusion, disability awareness, special dietary needs, code of conduct, and COVID-19 response. Most of Camp Trusted Parents staff are trained and certified in the American Heart Association, the American Red Cross First Aid/CPR/AED, and/or Crisis Prevention Intervention (CPI).

### GENERAL COVID MANDATES

#### **COVID-19 TEST**

We are asking that campers, families, staff, volunteers, and collaborative vendors to self-monitor for symptoms of COVID-19 beginning 14 days prior to the start of camp. If evidence of symptoms occurs, consult a physician for testing options, and please do not attend our camp until a negative COVID-19 test has been presented and confirmed. We are asking all camp participants to produce proof of a negative COVID-19 test, dated no more than 72 hours prior to the start of camp.

#### **MASKS**

Due to COVID-19, we have implemented safety measures to ensure the health and wellbeing of our camp participants. Masks are required at camp. Campers should wear face covering over their nose and mouth when within 6-ft. of others. Exceptions may be made when activities are outdoors.

#### **SOCIAL DISTANCING**

Social distance of at least 6-ft will be maintained between our non-pod camp groups campers

#### **HYGIENE**

Hand washing or hand sanitizer will be provided to all camp participants. Frequent hand washing by staff and campers, with adequate supply of soap/paper towels and/or disinfectant/ hand sanitizer is strongly encouraged and will be provided.

### REGISTRATION & PAYMENTS

Due to our limited camp size, space(s) cannot be held without payment. All registration fees and tuition payments must be paid in full by 10:00am, Saturday June 5, 2021, no payments will be accepted afterwards. Due to COVID-19, we are unable to schedule payment arrangements. NO REFUND WILL BE ISSUED ONCE CAMP HAVE BEGUN on JUNE 14<sup>TH</sup>. Paperwork needed to complete enrollment must be received by June 5<sup>th</sup>, paperwork not received can delay the start date of your child(ren). Please go to “Camp Forms” on our website for the list of all required documents needed.

FEES: There is a \$80 NON-REFUNDABLE, NON-TRANSFERRABLE REGISTRATION FEE required to secure your child’s enrollment. Each additional child thereafter will pay \$70. Each weekly session cost \$285, with a 10% discount for each additional camper registered.

### CANCELLATION POLICY

Parents will be notified immediately; in the unlikely event camp must be cancelled due to COVID-19 safety response. If by chance that happens, tuition paid, minus a 30% process fee and registration fee, for the remaining weekly sessions will be refunded. However, if your child becomes ill with COVID-19, while attending camp, NO REFUND WILL BE GRANTED. A partial refund (refund minus a 30% service charge and registration fee) will be issued when the registrant submits a written request for a refund a minimum of ten (10) days before start of the program. There will be NO FULL REFUNDS GRANTED AND NO PARTIAL REFUND GRANTED less than (7 days) before the first session or after the first session of any service week. There is **ABSOLUTELY NO REFUNDS** given after the start of camp. *(All cancellations requests must be submitted in writing by email)*

### ARRIVAL & DISMISSAL

Since the beginning of Camp Trusted Parents, McEwen has been our home; but with bitter sweet emotions we must say goodbye. After careful consideration of the safety and wellbeing of our campers we have decided to move to our new location in Rogers Hall. Please view the [campus map](#) to see where we are now located.

Due to COVID-19 we are required to put in place new safety regulations for the well-being of our camp participants. We have adopted using Fever Free (a virtual temperature check & symptom screening app) to conduct the CDC recommended health screen check on our camp participants. Campers will be required to conduct at home pre-health screening before arriving at camp daily. Parents must display the clearance badge before campers will be allowed access to the camp. Campers with failed health screens will be denied access to camp.

***\*Campers' arrival and dismissal site is located at the side entrance of Queens University at 228 Radcliffe Ave, Charlotte NC, 28207, at the Evans Clock Tower parking circle. \****

#### Arrival

Campers can start arriving between **8:45 am – 9:15 am**. If your child is going to be later than 9:10 am, please notify the camp as soon as possible. Counselors will be at the arrival site to receive campers and to check the pre-health screen clearance badge on your phone. Please do not leave your child at the arrival location without the presence of an authorized adult. We will not be responsible for children dropped off without properly being checked in. **THIS IS FOR YOUR CHILD'S SAFETY!!!**

#### Dismissal

You will be given a car pass with your child's camp ID Number to help counselors identify the car the camper belongs to. Please drive to the counselor with the Check In/Out sheet. A photo ID is required to pick up camper(s) until counselors familiarize themselves with you and your vehicle. **YOU MUST SIGN YOUR CHILD OUT OF CAMP DAILY!!!! THIS IS FOR YOUR CHILD'S SAFETY.** Authorized persons must be 18 years or older to sign out a camper at all times.

#### ABSENCES

If your child is not going to attend camp for the day, please report their absence to our camp staff by calling or texting 980-229-7253. Scholarship campers cannot miss more than 5 days of camp during the 4 weekly sessions awarded. If more than 5 unexcused days of camp are missed, their scholarship will be forfeiting. **NO EXCEPTIONS.**

### HALF DAY CAMPER ARRIVAL & DISMISSAL

There are two half day sessions; morning and afternoon. Drop off for our morning half-day campers is between 9:00 – 9:15 am, pick up is from 12:45 – 1:00 pm. Our afternoon half-day campers' drop off time is between 12:45 – 1:00 pm, pick up is at 4:00 pm. All drop off/pick up rules apply to our half day camper as well. With the exception to our morning half-day campers late pick up time start at 12:46 pm. **Half day campers are welcomed to in field trips activities and stay the full camp day; however, parents are responsible for the full cost of the "field trip" activities.**

### EARLY & LATE PICK-UP

In order for your child to be released from camp early, you must give a counselor written notice that morning. In case of emergency, call the camp office so that we can have your child ready.

CAMPERS MUST BE PICKED UP BY 4:00 PM. Failure to pick up your child by 4:00 pm will result in a late charge of \$1 for every minute starting at 4:01 pm. This will be charged per child and must be paid at the time of pick-up. If this occurs more than two instances in one week, it will result in a non-refundable removal from the camp. This rule also applies to our after-camp-care and half-day campers starting 1 minute after the designated pick-up time.

### BEFORE & AFTER CAMP CARE

Our camp program runs from 9:00 am – 4:00 pm. Before-and after camp care is available from 7:45 – 9:00 am and from 4:00 – 5:00 pm. Parent must enter the building with their child(ren) to drop-off and pick-up for “Before & After Camp Care”. **Parents must indicate on registration form if your child will require before and after camp care and pay the \$45-weekly fee. There is no daily rate for Before and After Camp Care. Late pick-up time starts at 5:01 pm.**

### CAMP CLOTHING

We ask that you dress your children in comfortable and appropriate clothing suitable for outdoor exploring and recreational activities. Lightweight clothing, closed-toe shoes, and sunscreen are essential. Please send children with light rain jacket or sweater when weather permits. Please label your children’s belongings. Tennis shoes **MUST** be worn at ALL TIMES (except, when swimming). **NO JEWELRY, FLIP FLOPS (except when swimming), DRESSES OR SKIRT worn to camp.**

Please do not send any **toys, cell phones, iPod, iPad, money, jewelry, or sport equipment** with your child. Camp Trusted Parents will provide all materials needed for activities unless otherwise specified in a letter to parents from the Camp Director. **Camp Trusted Parents and their affiliates will NOT be responsible for any lost, stolen, or broken personal belongings. Camp Trusted Parents is not responsible for reimbursement of any lost, stolen or broken personal belonging brought to camp.**

### CAMP T-SHIRTS/BADGES

It is **MANDATORY** that your child wears his/her name badge to camp every day. A lost badge will cost \$10 to replace. It is mandatory your child wear his/her T-shirt every Wednesday. One t-shirt is given free per child; additional t-shirt cost \$15 for youth sizes, and \$18 for adult sizes.

### LUNCH/SNACKS

Due to the challenges presented by COVID-19, we are requiring campers to bring lunch from home. You are responsible for providing a lunch for providing your child with a nutritional lunch Mon-Thursday. Your child’s name should be visible on their lunch bag/box so that staff can easily identify it. If food items require refrigeration, it is best to place ice packs in the lunch box to keep it cold. We will provide lunches for campers on Fridays. **Please try not to send any food that contains any form of peanut products, as this is a fairly common food allergy.** We will provide a light snack twice a day (mid-morning and mid-afternoon) every day.

### FIELD TRIPS

Due to COVID-19 concerns at potential field trip locations, as well as limited fleet availability with our transportation provider, off-site field trips will unfortunately not take place this summer. However, we will bring in some activities/presenters in for the children to enjoy each week (e.g., animal petting, Lego Land, carnival activities, and so much more).

### CAMPERS EXPECTATIONS

Good behavior will be encouraged in a positive manner. Before the first day of camp, you and your child are required to read through and discuss what the camper expectations are for camp. This way you will both be aware of the rules and consequences of Camp Trusted Parents. The staff will work cooperatively with parents, keeping them informed of behavior problems and methods used to teach and guide campers toward socially acceptable behavior. Behavior problems that cannot be resolved cooperatively will result in your child's dismissal from our program. Certain abusive and aggressive behaviors will result in immediate dismissal.

This year, only new campers will be required to submit their most current IEP or Psychological Evaluation to our office for review. Enrollment to our camp will be delayed until we have received the necessary documents. If your child has been receiving assistance in behavior management during the school year, it is imperative that this information be shared with the camp staff. Having this information will enable us to work more effectively and productively with your child. All campers must fall inline of the **ACCEPTABILITY GUIDELINES** for Camp Trusted Parents. They are as follow:

- All children must be fully independent and requires no assistance when it comes to **toileting and personal hygiene**, regardless if a community respite assistant come along with camper.
- All children must be enrolled in school
- Must not have violent or aggressive behavioral issues like, **scratching, punching, biting, hitting, grabbing others, and throwing things.**
- Must not **run away/ risk of flight.**
- Must **not use profanity, strip down clothing, or exposes self in public**
- Must not **touch others inappropriately**
- Must be able to engage in-group activities, and participate in one-on-one peer activities

Dismissal from our program may result from any violation of the acceptability guidelines, if it is found that a camper is unable to comply or adjust to the rules of the guidelines set forth. **No refund will be given if a camper is dismissed from the program due to his or her inability to comply to the acceptability guidelines.**

### CODE OF CONDUCT

**Our code of conduct does not permit language or actions that can hurt or frighten another person or that falls below a generally accepted standard of conduct. Specifically, this includes;**

- Angry or vulgar language including swearing, name calling, and shouting
- Physical contact with another camper in an angry or threatening way
- Any demonstration of sexual activity or sexual contact with another camper
- Harassment or intimidation with words, gestures, body language or other menacing behavior
- Behavior which intends to or result in the theft or destruction of others property

- Carrying or concealing any weapons or devices that may be used as a weapon

Campers are responsible for their own personal comfort and safety and should ask any person whose behavior threatens their personal comfort to refrain. Staff and volunteers are trained and expected to respond to any reported violation of our code of conduct. Please do not hesitate to notify a staff person if you need assistance. We are willing to help! Trusted Parents management will investigate all reported incidents. Dismissal from our program may result from any violations of our code of conduct. **No refunds will be given.**

### BULLYING

Bullying is when one or more people exclude, tease, taunt, gossip, hit, kick, or put down another person with the intent to hurt another. Bullying happens when a person or group of people want to have power over another and use their power to get their way, at the expense of someone else. **At Camp Trusted Parents bullying is inexcusable, and we have a firm policy against all types of bullying.**

Our camp's philosophy is based on our mission statement, which ensures that every camper is accepting no matter their differences. We are open to all wanting to develop the spirit, mind and body. We work together as a team to ensure that campers gain self-confidence, make new friends, and go home with great memories. Unfortunately, persons who are bullied may not have the same potential to get the most out of their camp experience. Our leadership addresses all incidents of bullying seriously and train staff to promote communication with other staff members and their campers so both staff and campers will be comfortable alerting us to any problems during their camp experience and between camp seasons. Every person has the right to have the best possible experience at camp, and by working together as a team to identify and manage bullying, we can help ensure that all campers and staff have a great summer at our camp.

### DISCIPLINE POLICY

If your child needs to be discipline, acceptable measures may include; stern verbal warning, time-out from activity, removal from activity and placed with staff away from group, suspension from camp, removal from camp. Unacceptable measures may include verbally degrading the camper, physical punishment, isolation without proper supervision.

We will make every effort to help your child adjust to our camp. Camp Trusted Parents reserve the right to withdraw a camper from our program if he or she is unable or unwilling to adjust to our schedule and program. Please read the acceptability guideline above.

**The following discipline policy will be followed for general misbehavior**

1. **Counseling:** When a discipline incident occurs, the camper will be made aware of the inappropriate behavior and given a chance to correct and change behavior once give description of the behavior change required.
2. **Time-Out:** If subsequent incidents occur the camper may be asked to take a TIME OUT. A TIME OUT is 5 to 10 minutes period that the camper spends quietly reflecting on the incident. The camper then rejoins the group.
3. **Parent Contact:** If a series of discipline situations occur, the camper's parent or guardian will be contacted. This is to be done in conjunction with the Head Counselor or Camp Director.
4. **Suspension:** A camper who continually disregards instructions or cannot adhere to the rules set forth, will be suspended for 1 day. The parent/guardian will be advised.

- Termination:** If the camper's behavior remains unacceptable then the parent/guardian will be informed and the child will be dropped from the program.

**More serious behaviors may result in immediate Camp Suspension. NO REFUNDS WILL BE GIVEN.**

## ILLNESS/INJURY

### ILLNESS

A child that is ill during camp will be separated from other campers and a parent will be notified to pick them up immediately. The camper must be fever, vomit and diarrhea-free for 24 hours before returning. If a camper vomit, they must go home immediately. If you are unavailable, we will call the emergency phone contact on your child's information form. Please be considerate of other campers and staff and keep your child home if they show signs of illness the morning of camp. If you are keeping your child home due to illness, please contact the camp by 8:30 am to let the staff know of your child's absence. A camper must receive appropriate treatment, depending on the condition, before returning to the program and may require a medical release from a physician. Paramedics (911) will be called to handle serious injuries. If a camper need emergency medical care, the camp director will accompany them to the medical facility, where they will meet you or the guardian.

### COVID-19

The above procedures will also apply for COVID exposed campers... However; If a camper has a fever of 100.4°F or above, or they have been exposed to COVID-19, they cannot return to camp for two weeks, per CDC guidelines. If your child tests positive for COVID-19, or has been around someone who has tested positive for COVID-19, notify the camp director immediately so others can be notified of the exposure. The camper will not be identified. Below is a list of symptoms both Communicable and COVID-19 to watch for:

Although; we are facing a global pandemic we are well aware that every symptom does not point to a positive COVID-19 diagnosis. However; please notify the camp director if your child or any member of your immediate household develops any of the above conditions. You the parent are responsible for notifying the camp immediately or within 24 hours or the next business day. It is important for us to post notice to other parents as soon as possible.

### INJURY

All precautions will be taken to prevent serious health risks to all campers. In the event that a minor injury occurs, First Aid will be administered at the location injury occurred by the camp staff. The following procedures will be followed:

- First Aid will be provided and the incident recorded in the camp log.
- The child will periodically be observed after First Aid has been applied.

In the event of a medical emergency, immediate action will be taken by the staff as per your orders on the camp registration form and policies and waivers. Please be sure to keep these forms updated at all times. If parents or other responsible adults are unable to be reached, the child will be taken to the nearest hospital for any necessary treatment.

In general, in the event that a major injury or health problem arises and professional medical care is required, the following steps will be taken:

- Immediate First Aid will be administered by the camp staff person until professional services arrive.
- Campus Police will be called.
- You will be contacted. If you cannot be reached, the emergency contact person will be notified.
- A staff person will accompany your child to the hospital and remain until you or your emergency contact person arrives.
- The incident will be described in writing on the Camp Trusted Parents incident report.

Emergency information is very important for us to provide the safest possible environment for your child(ren). Please notify us right away when there is a new work or home phone number, or if you have moved and have a new address. If your child is sick or injured, it is important for us to be able to contact you right away. Please keep these accurate at all times.

Camp Trusted Parents does not incur the cost of medical treatment and it is imperative that you indicate on your child's health history/registration form what type of health insurance you carry.

## HEALTH RECORDS/COVID-19 VACCINES

Each camper is required to have a Health History Form completed prior to starting our camp and up-to-date copy of immunization record on file with Camp Trusted Parents prior to the start of camp. Due to HIPPA regulations, Camp Trusted Parents will keep all campers forms secure. However, any information regarding allergies and/or specific medications that a camper may have or need will be dispersed accordingly to camp staff for the safety of your child(ren).

### COVID-19 VACCINES

Although COVID-19 vaccines are recommended and encouraged by the CDC, ACA, and state and local government officials, we have **decided not to mandate that our staff and campers be vaccinated at this time.**

According to the CDC, "**Although COVID-19 vaccines are effective at keeping you from getting sick, scientist are still learning how well vaccines prevent you from spreading the virus that causes COVID-19 to others, even if you do not have symptoms.**" For camp participants who have been fully vaccinated against COVID, should keep taking precautions until the CDC learns more, like wearing a mask indoors, avoiding large indoor gatherings, and washing hands often. Vaccinated campers do not need to wear masks outside except in crowds.

Everyone, including those fully vaccinate, will be required to wear masks and maintain and follow CDC's safety measures and recommendations as they pertain to summer camps.

### BABYSITTING

Trusted Parents employees who are responsible for the care, supervision or instruction of children are not permitted to perform similar duties, such as babysitting outside Camp Trusted Parents for the children who participate in the summer camp program, during the camp season. We ask that parents please follow these guidelines and recommendations set by Trusted Parents by not asking our staff to baby-sit your children.

### Camp Waiver & Release Statement

**Physical Condition:**

On behalf of my child(ren), I accept and assume any and all risks associated with his/her/their attendance and participation in Camp Trusted Parents or any program operated by Trusted Parents, Inc. (hereinafter "Trusted Parents") and all related activities. I understand that my child(ren) should not attend the camp if he/she/they are not in a healthy condition. Furthermore, I do hereby verify that my child(ren), to the best of my knowledge, is free from contagious disease, is fully immunized, and is able to participate in Camp Trusted Parents. Therefore, I hereby confirm that my child(ren): (i) has no psychiatric, medical, and/or physical condition or history which would prevent him/her from participating in Camp Trusted Parents and/or endanger himself/herself/themselves or others at Camp Trusted Parents; (ii) has not been instructed by any physician to refrain from participating in Camp Trusted Parents; and (iii) is physically fit and able to participate in Camp Trusted Parents.

volunteers, if any, and may not be foreseen or reasonably foreseeable by any of the foregoing entities or persons at this time or at the time of the Camp and any activities in which my child(ren) may participate.
