#### Adoption of the Agenda

Motion to approve the agenda of the June 6th Plan Commission meeting by Dan Turner and second by Glenn Bork – all are in favor. The motion passes.

# Approval of the Plan Commission Meeting Minutes – May 2<sup>nd</sup>, 2022 Meeting

#### **Guests and Public Comment**

<u>Guests:</u> Mae Strobel, Jeff Lee,

Mae Strobel expressed concern for the potential air and noise pollution resulting from the proposed gas station reconstruction. To date, no reconstruction plan has been presented to the Plan Commission for review. General knowledge of proposed construction would include commercial truck services. Ms. Strobel's concerns are based upon past uses of the site that generated noise and engine fumes at all hours.

# County Preliminary Meeting for Rezoning of Local Business

#### **Old Business**

## Vacant Seat on the Plan Commission

Jeff Lee, resident of Trail Ridge has expressed an interest in becoming a Plan Commission member. Jeff has provided the Plan Commission Chairperson and Village President with a letter requesting a seat on the Plan Commission. Chairperson Steve Zahn motioned for an informal vote to recommend Jeff Lee to the Plan Commission. All members in favor. Motion passes.

### Review of the Comprehensive Land Use Plan

Chairperson Steve Zahn introduced the remaining segments of the Comprehensive Plan.

Recapping last month's discussion concerning residential solar proposals, Glenn Bork disagreed with the present position of the Village to suspend residential solar proposals until the updated Comprehensive Plan is accepted. Mr. Bork commented that considerable time remains before the updated Plan is accepted and therefore prevents residents from securing solar projects over a reasonable time frame. Juliette Kerr noted that rooftop solar proposals are being permitted however, ground constructed systems are delayed. Mr. Bork commented that ground constructed solar systems may be the only option for some residential settings and therefore are unfairly delayed over rooftop systems. Mr. Bork will seek further detail about the Village solar permitting process.

With the review of the Comprehensive Land Use Plan draft complete, Chairperson Steve Zahn commented that additional photos, Village data, and regional data will be added. A request will be made of the County to produced an updated Land Use Map for the updated Plan. The Commission will now seek professional review of the completed Plan draft.
