**Ordinance No.: 1555**

**AN ORDINANCE REGULATING MOTOR VEHICLES FROM EXITING ONTO SAID STREETS AND TO PROHIBIT PARKING ON THE BELOW LISTED STREETS FINES AND PENALTIES ALLOWED BY THE MOTOR VEHICLE CODE.**

**BE IT ORDAINED AND ENACTED** by the City Council of the City of Connellsville, as is hereby ordained and enacted by the Authority of the same as follows:

**SECTION 1.** The following intersections are established as “Not an Exit” and such signs shall be erected in a position as to face traffic approaching the second named street. Every driver of a vehicle approaching said sign shall not proceed through erected signs.

<b>APPROACHING STREET</b>	<b>EXIT STREET</b>	<b>DIRECTION OF TRAVEL</b>
Ogden Street	East Crawford Avenue	East
Unnamed Alley Rear N 8 <sup>th</sup> St.	Rt. 119 South	North

**SECTION 2.** Any person who violates any provision of this section shall upon conviction pay a fine of \$25.00 Twenty-Five Dollars and costs.

**SECTION 3.** The following sections of Streets will be designated as no parking areas for motor vehicles.

Grape Alley	Carnegie Avenue	Dead End	North

**SECTION 4.** Any person who violates any provision of this section shall upon conviction pay a fine of \$15.00 Fifteen Dollars and costs.

**SECTION 5.** This Ordinance shall be effective ten days from the date of enactment by City Council.
