THAT EAGLE RIDGE DEVELOPMENT HOMEOWNERS ASSOCIATION, INC., under the authority of the Eagle Ridge Development Homeowners Association, Inc. Bylaws ("Bylaws") and pursuant to Article XI, "Amendments of Bylaws," Section I(i) of the original Bylaws by the requisite vote of the Members does hereby amend, change and revise said Bylaws as follows:

Article III - Annual Meeting of the Membership, Section 2, which reads as follows:

Section 2. Annual meeting of the Members shall be held on or about the 30th day of May, or if such day is a legal holiday, then on the next business day following, at 7:00 p.m., at which meeting they shall elect by a majority vote a Board of Directors and transact such other business as may properly be brought before the meeting.

Said Article III, Section 2 shall be amended, changed, and revised to read as follows:

Section 2. Annual meeting of the Members shall be held on or about the 1st Monday of October, or if such day is a legal holiday, then on the next business day following, after 5:00 p.m., at which meeting they shall elect by a majority vote a Board of Directors and transact such other business as may properly be brought before the meeting.

Article V - Quorum and Voting, Section 1, which reads as follows:

Section 1. A quorum for the transaction of business at meetings of the Members consists of three-tenths (3/10) of the Members in good standing, represented in person or by proxy, except as otherwise provided by statute or by the Certificate of Incorporation. If a quorum shall not be present or represented at any meeting of the Members, the Members present in person or represented by proxy shall have the power to adjourn the meeting without notice other than the announcement at the meeting.

If a quorum shall not be present or represented at any meeting of the Members, the Members present in person or represented by proxy shall have the power to adjourn the meeting without notice other than the announcement at the meeting.

UNLESS further amended and filed of record, all other provisions of the original Bylaws remain in effect.
