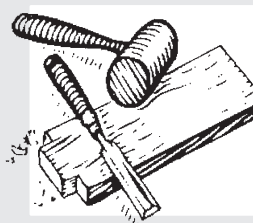

## St. Augustine Shores Service Corporation November 12th, 2015 Board Summary

The St. Augustine Shores Service Corporation's Board of Directors meeting was called to order by Vice President Jerry Zinn at 7:00 P.M. Present: Treasurer Claire Lorbeer, Director James O'Such, Secretary Rachel Diamond, Director Sue Chitwood via telephone. Excused Absences: President James Priestler, Director Winston Burrell. Quorum Established

The Invocation was given by General Manager Smith followed by the Pledge of Allegiance.

**Approval of the Minutes** – October 8, 2015. Motion: Treasurer Lorbeer made a motion to accept the minutes as presented. Seconded By Director O'Such. Unanimous. The motion carried.

**Treasurers Report** – Read by Treasurer Lorbeer accepted for audit. General Manager Smith explained the decrease in operating cash and the increase in the reserve funds.

### Managers' Report - Joseph H. Smith III

#### Old Business:

**Storm Water Drainage System Update** - General Manager Smith informed the Board that the dredging project East of Valverde Lane and the peninsula work South of Viscaya Blvd. are scheduled to commence mid-December. The level of the water table has caused the delay.

#### Progress on Board Goals -

**Curb Appeal** – Current projects include rye seeding the medians, installation of fresh mulch around the RVF landscape, and pine straw for all flower beds, entrances, and medians. The directional drill project for the irrigation well at 506 Shores Blvd was moved out to the week of November 16.

**Safety/Security** – Smith presented a quote from Village Key for a new card access system for the RVF Pool, the Pier, and the Boat/RV Storage Facility. He presented the details. Total cost \$9090.00. We will solicit more bids for the project.

**Operations** – Dreux Isaac Reserve Study Update scheduled for November 17, 2015.

**Action Status List Update** - Secretary Diamond provided the details for an updated color coded list.

#### Committee Reports - ACC – Vice President Jerry Zinn.

The ACC sent a variance request to the Board. Kelley 125 Deltona Blvd. requests a variance for a fence installation. They would like to install the fence in front of the only door that accesses the rear of the property from the house which is located 5 feet forward of the rear of the house. Motion by Secretary Diamond to grant the variance. Seconded by Director O'Such. Unanimous. The Motion carried.

The ACC Committee held one meeting in the month of October.

21 Applications approved. 1 variance request sent to the Board.

**Riverview Building and Grounds** – Secretary Diamond reported that the walk-in freezer and a cabinet had been removed from the kitchen to create more storage space. She discussed the need for a non-profit rental rate equivalent to the resident rental rate.

She presented a new rate schedule for the activities at the Riverview Facility. Motion by Director O'Such to establish a third rate classification for non-profits and that the cost be between the resident rate and the non-resident rate based on the room rented. Seconded by Secretary Diamond. Unanimous. The motion carried.

**Recreational and Social Organization** - Vice President Zinn informed the Board that the Recreational and Social Organization has offered to meet and detail duties that need to be covered for all activities. They would like to offer this information to assure that the new rates cover any costs associated with the different activities.

**Collection Issues** - General Manager Smith presented some collection issues

**Boat/RV Storage Compound** – Vice President Zinn commented on the goals of the committee. He informed the Board that we have engaged an engineer with Mathews Design Group to address the drainage issue. He discussed the benefit of a card access system.

#### New Business

The Deed Restriction Report was summarized.

#### Directors Comments

Director O'Such commented on changing the fence policy.

#### Members Comments

John Grexa commented on the Recreational and Social Organization. He commented on the deficit of the RVF pool. He feels we should add .75 cents a month to the maintenance fee so the pool can be open to all residents.

There was discussion on Deed Restriction Violations.

Meeting Adjourned.

### Wild Flower Meadow Group

Most of the fall blooms have come and gone, except for the bushy aster. Their tiny light blue blossoms remind me of an early snowfall that sprinkle tiny flakes across the tops of whatever is growing. Only the bushy asters don't melt into the ground, at least they haven't at the time of this writing early in November.

Fall is when seeds ripen, fall to the ground, and the wild flower meadow has a profusion of seed heads now. When sunlight shines on them just right, it's easy to imagine they're flowers in bloom and in a way they are. There's more to wild flowers than the blossoms. There are what we call "gone-byes" (seed heads) in the fall and buds in the spring.

Fall is when the wild grasses display their fall colors in their version of seed heads. In the meadow there are



muhly and love grasses with burgundy inflorescence. The tall clumping grasses are varieties of blue stems.

Again this year our thanks to the anonymous donor who gifted the meadow with a check to help support the care and maintenance of the meadow

Our group meets the first Saturday of each month at 8:30 by the Riverview Club House. Our goal is to care for the wild flower meadow, learn about native plants, and what grows in this location. 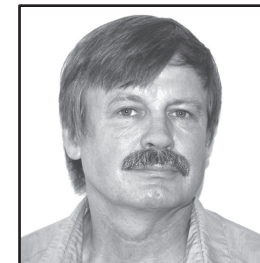

### Windows 10 Conversion Issues

Greetings from Computer Professor

This is the final update on windows 10 conversion - this article is on safe conversion techniques only, send me emails (mainely2@bellsouth.net cell 904-377-6785) with questions about operations of windows 10 and I will include answers to the most popular questions in my future articles.

There have been many safe conversions to Windows 10 and a few disasters; here is how to avoid those disasters:

Clicking the "Get Windows 10" icon in the lower right of your screen (you only have this for a windows 7 and above operating system) contains a PC compatible report available for your system, check this out first. Do NOT click on the upgrade button at this time.

The report available in step one is a long way away from knowing you will have a smooth upgrade, next go to the manufactures website for your computer (i.e. www.hp.com), usually at the top of the screen there will be a link named support. Follow this link and look for a section that says drivers. You should be able to either see a comment about Windows 10 or see where you can select drivers for Windows 10. If driver are available then the upgrade should succeed. Some of the failures came from trying to upgrade to Windows 10 when it was listed at the manufacture website the system was not tested for or

would not work for Windows 10.

Your computer needs to be in good operating shape. All recommended Windows updates have been installed, no viruses, malware or failing hard drives. If your computer is having problems, slow down and freezing from a bad hard drive it is a good chance the upgrade will fail and reverting back will NOT be an option, all will be lost.

It is true if you upgrade and don't like it, you can revert back within 30 days, but if your upgrade fails you could lose all your files and installed programs. The safe method would be to also include backing up all your personal data and make sure you have the originals CDs to reinstall your programs before attempting a Windows upgrade.

Before upgrading, make sure you have checked with the manufacture website for any printer and other peripheral you have attached to your computer for a Windows 10 driver, most computers will need to reload or update the printer driver.

I wish you all the best of luck; this is an easy operating system to use once you have learned how to use it. So learn how to use it and have fun.

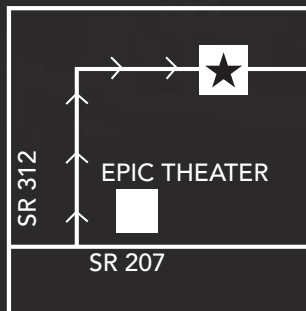

## Breaking the Mold

I have been around Pilates ever since high school. I worked in a Pilates studio and took classes prior to becoming a physical therapist (PT). I knew of its benefits then but never realized how far reaching they were until I finished my PT degree. It was only then that I began to pursue additional education in this area, within the framework of my PT knowledge. It rekindled my love for this form of exercise. I was once again amazed how this simple, yet challenging form of exercise could be used to help so many people, healthy or recovering. Pilates helps strengthen muscles in a very gentle way, using low-impact resistance. It is so easy to incorporate into a rehabilitation treatment and the benefits are wonderful.

Pilates was developed by Joseph Pilates. He understood the anatomy and biomechanics of the body and incorporated this in his exercises. At that time, he "broke the mould" of exercise. Physical Therapist have gravitated to the use of Pilates and Reformer because of their own understanding in these areas, breaking the mould once again.

One of the many pieces of equipment used in Pilates is the Reformer. It is called the Reformer because it 'reforms' the body. It uses graduated resistance from springs to challenge muscles and promote strength throughout the body. The number of springs can be varied in order to increase or decrease the amount of tension. Exercises are done in a way to incorporate many muscle groups so as to develop strength,

coordination, and balance. This is what makes it so great for rehab as well as every wellness. One other thing it encourages is flexibility. Many exercises are very straight forward, such as simply sitting in kneeling on the Reformer sled, sliding it forward and back through the movement of your arms – all the while keeping a stable trunk.

So how can Pilates be used in rehab, everyday wellness, and who can do Pilates? The answer to the first question is so individualized it cannot be answered in the limited 500 words or less of this column. But the answer to the second question is "anyone". Whether you are working to increase athletic performance in school sports, wanting to improve your posture, or are even recovery from surgery, Pilates is most likely a great fit for you.

Pilates is able to work with various types of posture in order to help restore a normalized movement pattern by incorporating all movements of the spine. The "core" is called that for a reason. All movements must come from a stable "core" or trunk. Unfortunately, "core" stabilization is lost as we age, become less active, endure injuries or faltering postures, and more. Pilates can help improve and maintain core stability while enabling mobility. It helps tone muscles too, which never hurts.

I'm excited to be able to use Pilates at First Coast Rehabilitation and if you'd like to see what I'm doing, think it might help you, or if have questions, give me a call.

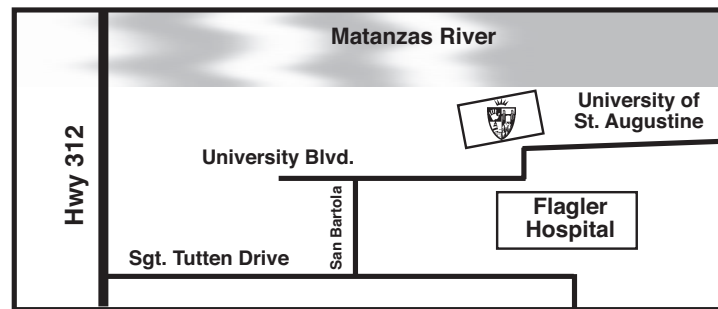
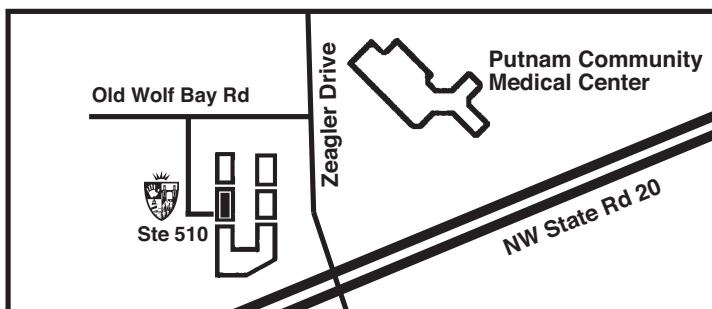

### Holiday Crime Prevention



We are coming up on one of the most festive times of the year for families with the celebration of several holidays. However, joy and fun can quickly turn to disappointment and sorrow when someone becomes a victim of a scam, burglary or online fraudulent holiday shopping scheme.

At a time of year when most people are filled with goodwill there are criminals who relish taking advantage of it. Crime statistics always rise during the holiday season and I wish to pass along a few tips to help you avoid becoming a victim. Business experts tell us that again this year the number of people who shop online for gifts will increase dramatically and therefore so do the opportunities for those who use new technology to take advantage of unsuspecting victims. The cyber-crimes that become more popular during the holiday shopping season include fraudulent auction sites, resale of stolen or counterfeit gift cards and reshipping merchandise purchased with stolen credit cards. Do not become a victim. I recommend that if you wish to purchase a gift through an auction or classified site on the Internet insist on paying with PayPal or some other reputable third party payment service. That way your credit card number and personal information is not shared with the seller.

Most of you already know the safety tips for traditional retail shopping: take your purchases to your vehicle frequently and lock them in the trunk or out-of-site; carry purses with the strap going over one shoulder and the purse against your body

on the opposite side; carry billfolds in a front pants pocket; pay by credit card or check if at all possible; and if you must use an ATM always shield the keypad when entering your PIN and put cash away promptly in your purse or wallet.

Home burglaries are more common during the holidays and sadly the thieves target the gifts under the tree. If you are going to be away from home, leave some lights on and a radio or television to make it appear and sound as if someone is home. After the celebration do not put the boxes of expensive gifts out for street garbage pickup without first breaking them down and folding them so only plain cardboard shows so they don't become an unintended billboard for what you have in your home.

Holiday parties can be wonderful fun but please remember to celebrate safely and if alcoholic beverages are served, moderation is the best practice. The concept of "friends don't let friends drive drunk" becomes even more significant. We will have impaired driver patrols out in full force to help keep your family safe during the holidays.
