AN ORDINANCE AMENDING VILLAGE CODE

(Chapter 5—Fees, Subchapter 1—Building Permits)

BE IT ORDAINED by the President and the Board of Trustees of the Village of Lily Lake, Kane County, Illinois, that the Village Code, as amended, be further amended as follows:

§ 1. Amending Village Code

The schedule attached as Exhibit A entitled Application Requirements and Permit Fee Schedule (the "Fee Schedule"), is adopted as a statement of the requirements for the issuance of a building permit within the village and the fees to be paid therefor. The fees set forth in the Fee Schedule replace those specific fees in § 500 of the Village Code (Chapter 5—Fees, Subchapter 1—Building Permits). Any fee currently set forth in § 500 that is not included in the Fee Schedule remains in effect and unchanged.

§ 2. Repealer

Any ordinance or any provision of any ordinance in conflict with the provisions of this ordinance is, to the extent of such conflict, repealed.

§ 3. Effective Date

This ordinance is fully effective from and after its passage, approval and publication as provided by law.

Application Requirements and Permit Fee Schedule

Application requirements:

- Completed application
- 2 sets of building plans
- 2 sets of site plans drawn to scale and including the items listed on the "Engineering Site Plan Checklist for Primary Structures" or the "Engineering Site Plan Checklist for Secondary Structures" as applicable.
- Street Bond required for new homes and on a case-by-case basis for additions (due when permit issued)
- Engineering/Building Review Fee Deposit
- Architectural review approval from the Homeowner's Association (Sunset Views I and II and Trail Ridge Estates)
- Permit Deposit (\$500 secondary structure; \$1000 new construction)

For new homes you will also need to submit:

- Kane County Well & Septic Permit copy
- Kane County Dept of Transportation Road Improvement Impact Fee Receipt (due when permit is issued)
- Architectural review approval from the Homeowner's Association (Sunset Views I and II and Trail Ridge Estates)
- Culvert application
