**– About the speakers –**

**Professor Mads Andenas, QC** holds a Chair in the Faculty of Law, the University of Oslo, Norway. He is a director of the London Centre for Commercial and Financial Law and remains a Visiting Research Fellow of the Institute of European and Comparative Law, University of Oxford and a Senior Research Fellow at the Institute of Advanced Legal Studies, School of Advanced Studies, University of London. He has held senior academic appointments in the United Kingdom, including as Director of the British Institute of International and Comparative Law, London and Director of the Centre of European Law at King's College, University of London.

**Professor Iris Chiu** is Professor of Company Law and Financial Regulation at the Faculty of Laws, at University College, London (UCL). She is the director of the UCL Centre for Ethics and Law. She is also Research Fellow at the European Corporate Governance Institute and has recently been appointed as Senior Scholar to the Legal Research Programme at the European Central Bank. She has published extensively in banking, capital markets and investment regulation, such the jointly authored book *Corporate Governance and Investment Management* (Edward Elgar 2017) with Mads Andenas and an authoritative textbook *Banking Law and Regulation* (Oxford University Press 2019).

**Professor Jan H Dalhuisen** is Professor Emeritus at Kings College London and Chair in Transnational Financial Law at the Catholic University in Lisbon. He is the author of the seminal Hart title: "Dalhuisen on Transnational and Comparative Commercial, Financial and Trade Law" in three volumes. Prof. Dalhuisen is also Visiting Professor at the University of California Berkeley and former Visiting Professor at the Tsinghua University in Beijing, the University of Hong Kong, the University of Singapore (NUS), Tel Aviv University, the University of New South Wales in Sydney, Australia, and the University of Utrecht in The Netherlands.

**Professor Olha Cherednychenko** holds the Chair in European Private Law and Comparative Law at the University of Groningen, The Netherlands. She is also Founding Director of the Groningen Centre for European Financial Services Law (GCEFSL). The research of Olha Cherednychenko focuses on the role of private law in the process of European market integration and the interaction between national and supranational legal orders and public and private governance mechanisms more generally.

**Dr. Federico Della Negra** is a Legal Counsel at the European Central Bank and obtained his PhD in law at the European University Institute in Florence, Italy. His thesis has been published as "MiFID II and Private Law: Enforcing EU Conduct of Business Rules" with Hart Publishing.

**Dr. Maren Heidemann** is a director of the London Centre of Commercial and Financial Law. Dr Heidemann has held a number of full time and visiting academic appointments in the UK since 2007 including Lectureships at the University of Westminster and University of Glasgow. Dr Heidemann has been working for the University of London since 2010 in various roles including as research fellow at the Institute of Advanced Legal Studies (IALS), School of Advanced Studies, University of London and as Teaching Fellow and tutor at the Centre for Commercial Law Studies (CCLS) at Queen Mary, University of London. She is the author of *M Heidemann, Transnational Commercial Law* (Palgrave MacMillan, London 2018).
