2021 – Cty Rd 8 and 40 roundabout

2022 – Reconstruct Cty Rd 8 from freeway to Cty 7

2023 - blacktop Cty Rd 8 from freeway to Cty 7 in spring, reconstruct Cty Rd 8 from 40 to freeway

2024-2025 – blacktop Cty Rd 8 from 40 to freeway
