#### HOLDING AGREEMENT:

A \$200.00 deposit is required to hold your puppy. The seller assigns the buyer the <u>Dog</u> <u>Guarantee</u> that the dog will not be sold to any party other than the buyer as long as the buyer adheres to the <u>Picking Up Your Puppy</u> guideline. **The \$200.00 deposit is nonrefundable** and will be applied to the purchase price of the dog when the buyer assumes physical possession of the assigned dog. If the buyer does not show-up as scheduled to pick-up the puppy and has not contacted the buyer within 24 hours of not showing the deposit is non-refundable and the buyer has the right to find another buyer.

#### PICKING UP YOUR PUPPY:

Your assigned puppy will need to be picked up during the 8<sup>th</sup> weeks of age. If your puppy is not picked up by the 8<sup>th</sup> week and no prior arrangements have been made with the seller Springer Hills Farm has the right to void the Puppies Sales Contract and find another buyer. In this case the deposit is non-refundable. If prior arrangements have been made with the seller the buyer will be charged boarding fees of \$25 daily extended

from the 8<sup>th</sup> week of age. All fees are required to be paid in full before the puppy is released to the buyer.

## SHIPPING YOUR PUPPY:

Shipping arrangements can be made for your puppy. Shipping charges and all associated fees are charged to the buyer and are due before shipping can occur. The shipping fees associated with your puppy will be listed in the Puppy Sales Contract. Your assigned puppy will be shipped at 9 weeks of age. If your puppy is not shipped by the 10<sup>th</sup> week and no prior arrangements have been made with the seller Springer Hills Farm has the right to void the Puppies Sales Contract and find another buyer. If prior arrangements have been made with the seller the buyer will be charged boarding fees of \$25 daily extended from the 10<sup>th</sup> week of age. All fees are required to be paid in full before the puppy is released to the buyer

## FIRST RIGHT OF RECOVERY:

If the buyer is unable to care for or chooses to change his/her mind about caring for the puppy purchased Springer Hills Farm retains the right for recovery of the puppy at the buyers' expense. The buyer must notify Springer Hills Farm as to the change in circumstance and give the seller first right to the dog before any other action is taken. This includes and is not limited to selling the dog to another buyer. The original purchase price of the dog is non-refundable if there is nothing wrong with the puppy/dog and the buyer is just unwilling or unable to care for the animal. To protect both the dog and the kennel's reputation we have included this clause. We do not want our puppies sold to a puppy mill, or turning up in a pound, humane society, pet shop, or auction.

## LIMITED REGISTRATION

All puppies are sold with Limited Registrations unless contracted otherwise. Springer Hills Farm will hold all AKC Registration papers until the buyer provides a statement from your vet proving that your puppy has been spayed/neutered. No exceptions unless contracted otherwise.

## **LEGAL**

If for any reason the buyer or the seller have a dispute that needs to be addressed with a court the buyer agrees that ALL legal proceedings will be conducted in the county in which the seller resides.

\_\_\_\_\_The puppy is sold on <u>Limited Registration</u>. It is understood that the puppy will be Spayed/Neutered and NOT to be used for breeding. Puppy is to be spayed or neutered no later than eight months of age. You are to furnish the breeder with a copy of the spay/neutered receipt.

\_\_\_\_\_The puppy is sold on **Full Registration** in which it will be eligible for all registry events and offspring will be eligible for registration.

\_\_\_\_\_ The puppy will be picked up by the buyer at the seller's location. Buyer understands that he/she will need to adhere to the Picking Up Your Puppy guidelines as listed above.
