By attending and / or participating in this event you knowingly and freely assume all such risks, both known and unknown, and you voluntarily enter at YOUR OWN RISK.

You assume sole responsibility for any injury, death or property damage you may suffer as a result of your attendance and / or participation in this event.

Upon entering this designated area you acknowledge the event organisers and / or others do not accept any liability for any accident, damage, injury or illness to you, any spectators, participants, horses or any other person or property whatsoever.

You agree to follow the directions of any event organiser or official and that any misconduct or refusal by you to follow any direction of any organiser or official can result in the cancellation of your participation in the activities and your immediate removal from your horse no matter where that may occur. You understand that any such non-compliance may result in injury, death and/or permanent disability as a result of your failure to comply.

## Rules and Conditions of Entry

1. The West Australian Arabian Horse Association Inc (WAAHA) or any of its Agents, shall not be liable for any financial loss or damage, physical injury or property damage suffered by any person or animal by reason of any defect, accident, natural disaster, negligence, or neglect however arising.  
Entry to the event is done with the exhibitor/participants knowledge that a pandemic named Covid-19 is still active in Australia and neither The Affiliate, The AHSA Ltd. or the Show Committee will be held liable for any Covid-19 related incident that may occur as a result of participation. All current government restrictions in place at the time of events will be adhered to.
2. The WAAHA Committee reserve the right to cancel, alter or combine any event(s) they deem necessary on the day.
3. All Participants must be AHSA or EWA members or pay Day Membership to AHSA.
  - All Participants must complete the Release and Waiver of Liability form
  - Participants who are not a member of AHSA must provide proof EA membership and complete the Liability Declaration for Day Members form
  - Participants who are not members of AHSA or EWA must complete the Liability Declaration for Day Members and Application for Day Members form and submit the relevant fee of \$12.00 per person per day.
4. APPROVED SAFETY HELMETS MUST BE WORN BY ALL COMPETITORS
5. All classes will be run as per the current EA National Show Horse Rules.
6. EA Height certificates are required for all official horses and must be shown when collecting numbers.
7. Horse/rider combinations who have competed officially in the past 12 months cannot enter the unofficial classes.
8. Unofficial horses do not require a height certificate, however horses are to compete in the correct height class.
9. Walk/Trot Horse/Rider combinations can not compete in any W/T/C classes (including WAAHA HOTY Classes)
10. Leading Rein Riders must be 5 – 8 years old. Handler must be over 18 years.
11. Proof of age for Junior Riders must be presented, if required on the day – Age as on the day.
12. Protests must be received in writing within 30 minutes of the conclusion of the event in question, with a \$100 fee attached. Refund will only occur if the protest is upheld.
13. WAAHA reserves the right to interpret the rules and make a decision where any dispute arises. Under no circumstances is approaching the judge or coaching from the side of the ring permitted.
14. Lunging is not permitted on the main oval. There will be a dedicated area to lunge advised prior to the event.
15. Riding on the grounds is not permitted if you are not entered.
16. Refunds of 50% will be offered after close of entries if a vet/doctors certificate is presented prior to the commencement of the event.
17. In the case of an exhibitor being required, by law, to self-isolate or be in quarantine due to COVID-19 risk or exposure, a full refund will be provided upon proof of such legal requirement.
18. PERTH POLO CLUB (KINGS MEADOW) – CONDITIONS OF USE  
**ALL MANURE, HAY AND RUBBISH MUST BE REMOVED FROM THE GROUNDS BY THE EXHIBITOR.**  
Ensure any holes dug by horses are filled in prior to leaving.  
Camping is welcome – the toilets and shower will be available for use. There are no powered sites or permanent yards, exhibitors will need to provide their power source and own safe yards if they are camping (must be attached to the float and made of solid panels - no electric only fencing). There is to be no camping near the river. There are wash bays and hoses available for use.  
**Do not leave any manure/hay piled around trees or bags full of rubbish/manure/hay on the grounds, IT MUST ALL BE REMOVED BY THE EXHIBITOR.**

**Where possible, classes will be scheduled to prevent horses classes from clashing in the WAAHA HOTY in Ring 1.**
