Dr. Duranda Greene was appointed as the first female President of Bermuda College in 2007 and has served at the institution for over 25 years. Her service included Assistant to the President for Special Projects, Dean of the Faculty of Hotel and Business Administration, Chair of the Business Division, academic advisor and a lecturer in management and bookkeeping.

One of the highlights of her Presidency occurred in 2010 when Bermuda College became an accredited institution of the New England Association of Schools and Colleges (NEASC); the first in the Caribbean and Latin American regions and only the seventh international higher educational institution to be so awarded. Other accomplishments under her leadership include: the introduction of the nursing programme; the accreditation by the American Culinary Federation of the culinary arts programmes; the introduction of online courses; and the introduction of a shared governance model of management. The College has also established a 10-year strategic plan and a 5-year academic plan; and has experienced an increase in enrollment under Dr. Greene's leadership.

Dr. Greene holds a Doctorate in Educational Leadership with a concentration in Higher Education from Argosy University, Sarasota. She also holds graduate degrees in Business Management from Boston University and in Education from Mount St. Vincent University. After graduating from Bermuda College she transferred to Acadia University where she completed her Bachelors in Office Administration before completing a second undergraduate degree, the Bachelors in Education, at Mount St. Vincent University.

Dr. Greene is a founding member of the International Women's Forum Bermuda Chapter and also holds several facilitator certifications including Strategic Planning, Appreciative Inquiry, Achieve Global Trainer, and Diversity Skills. She is also a Fellow Certified Administrative Manager from the Canadian Institute of Certified Administrative Managers.

She is an active member of Mount Zion A.M.E. Church where she serves as Treasurer, a member of the Steward Board, Altar Ministry, Sunday School Teacher and the Usher Board. She is also one of the founding members of the A.M.E. Home-work Club at Victor Scott Primary School.

She assumed the position of Development Director at the Bermuda National Gallery for five years, where she successfully managed and implemented their annual membership and corporate giving campaigns. In her role at Caron Bermuda, she has oversight of the Bermuda offices, building upon existing programs and offerings at the nonprofit addiction treatment facility through advocacy, business development and community relations.

Amongst her several citations, in 2007 and 2008, she was honored by the Bermuda Chamber of Commerce as one of the 100 Women "Who Rock the Rock" for her contributions made in philanthropy and entertainment in Bermuda. Keynote Speaker

United States Representative Yvette D. Clarke is a Brooklyn native whose roots are firmly planted in her Jamaican heritage. A product of the New York City Public School System, Rep. Clarke graduated from Oberlin College and was a recipient of the prestigious APPAH/Sloan Fellowship in Public Policy and Policy Analysis.

Rep. Clarke was first elected to Congress in November 2006 and represents the new Ninth Congressional District of New York which includes the communities of Brownsville, Crown Heights, East Flatbush, Flatbush, Gerritsen Beach, Madison, Midwood, Ocean Hill, parts of Park Slope and Flatlands, Prospect Heights, Prospect-Lefferts Gardens, Sheepshead Bay, and Windsor Terrace.

Prior to being elected to the U.S. House of Representatives, Rep. Clarke served on the New York City Council representing the 40th District in Brooklyn. She succeeded her pioneering mother, former City Council Member Una S. T. Clarke, making them the first mother-daughter succession in the history of the Council.

As the Representative for the Ninth Congressional District of New York, she is committed to continuing the district's legacy of excellence as set forth by the late Honorable Shirley Chisholm, the first African American woman and Caribbean American elected to Congress. As an activist, a community organizer and now as a legislator, Rep. Clarke's boldness, compassion and love for humanity has allowed her to become an effective leader and an outspoken advocate on numerous issues of great importance to her constituents.

Currently in the 113th Congress, Rep. Clarke sits on the Committee of Homeland Security, the Subcommittee on Emergency Preparedness, Response, and Communications, is the Ranking Member of the Subcommittee on Cybersecurity, Infrastructure Protection, and Security Technologies. Her additional committee assignments include the Committees on Ethics and Small Business, which includes the Subcommittees on Economic Growth, Tax and Capital Access as well as Contracting and Workforce.

As a testament to what Representative Clarke has accomplished in her first term, she received an "A" rating from the Drum Major Institute and The Middle Class.org; a 100 percent rating by Peace Action, The Brady Campaign and the American Civil Liberties Union (ACLU); and was the only Member of Congress in the New York Congressional delegation to receive an "A+" rating from the Institute of Policy Studies. She was also named After-School Hero by The After-School Corporation for her work on the House Education and Labor Committee. In May 2009, Rep. Clarke was also presented with an honorary Doctorate Law Degree from St. Francis College.

Rep. Clarke currently resides in the neighborhood where she grew up, in the Flatbush section of Brooklyn.
