### Garfield Fire Department request for fire protection.

They responded to a total of 104 calls in 2020 for all townships and the City of Garfield. The Garfield Fire Department's funding request for 2022 was \$25,540.92. A motion was made to give \$25,540.92 (m- Hardy Huettl, s- Jerome Kostreba, v- unan.)

## Brandon Fire Department request for fire protection.

No one was present to represent the Brandon Fire Department. The Brandon Fire Department is requesting an amount of \$11,562.04 for 2022. A motion was made to pay \$11,562.04 for 2022. (m- Bonnie Huettl, s- Lynn Bushard, v- unan).

### District 206 Community Education request for funds.

In December of 2019 Lakes Area Recreation dissolved and the community recreation programs fell back under control of the Alexandria Public Schools. The Alexandria Public Schools Community Recreation Programs are completely fee driven and they do not receive any additional state funding for their recreation programs. A letter had been received from Alexandria Public Schools Community Recreation Program requesting \$1,010.00 for the year 2022. A motion was made to pay \$1,010.00 for 2022. #### Holmes City First Responders

No request for funding in 2022 was received from Holmes City First Responders. Last year they had attended and stated that they were self-sustaining and were not asking for any funding in 2021. A motion to note that no request was received was made. (m- Lynn Bushard, s- Bonnie Huettl, v- unan.)
