YUCCA FIRE DISTRICT FEE SCHEDULE

1.1. ANNUAL BUSINESS INSPECTION FEES

In District

- a) Initial Inspection of BusinessNo Fee
- b) First Re-Inspection of BusinessNo Fee
- c) Second Re-Inspection Due to Non-Compliance.....No Fee
- d) Third Re-Inspection Due to Non-Compliance\$50.00
- e) Fourth Re-Inspection Due to Continued Non-Compliance.....\$100.00*
- f) Re-Inspection Fee\$200.00**

Out of District

- g) Inspection\$40.00/hour + \$35.00/hour per inspector

**At the discretion of the Fire Chief, the business or process may be "Red Tagged and/or STOP WORK ORDER" issued, pending compliance with the district fire code. **To restore business operations, a re-inspection fee shall be paid, and all corrections completed prior to issuing approval to re-open the business.*

Commercial Construction – Additions & Remodel Plan Review

Pools, spas, towers, fences, gazebos, restrooms and detached garages and outbuildings <1,000 sq. ft. in size.

Public Records Request

1.4.1. All individuals requesting public records for non-commercial purposes will be charged at the rates indicated above.

1.4.2. Public Record Request for commercial purposes—persons requesting reproductions for a commercial purpose must provide a statement setting forth the commercial purpose and will be assessed a fee that includes the following: a portion of the cost to the public body for

obtaining the original or copies of the documents, printouts or photographs; a reasonable fee for the cost of time, materials, equipment and personnel in producing such reproduction; and the value of the reproduction on the commercial market as best determined by the public body.

Emergency Medical and Fire Service Fees**

1.4.3. Fire and emergency response – (not BLM land)

- a. Preparedness and response fee\$250.00

- b. Apparatus: (all apparatus are billed in 15-minute increments with a minimum of one hour billed)
 - Fire Engine Type I\$450.00/hour
 - Fire Engine Type VI\$150.00/hour
 - Water Tender\$250.00/hour
 - Staff Vehicle\$100.00/hour

- c. Personnel: (all personnel are billed in 15-minute increments with a minimum of one hour billed)
 - Chief Officer/Duty Officer\$68.00/hour
 - Fire Investigator\$62.00/hour
 - Firefighter\$50.00/hour

Supplies

All supplies, including Foam & Water, are charged at actual department cost plus 10%.

** Emergency Medical and Fire Service Fees are not charged to residents of the YFD or residents under a subscription service and do not affect or alter the terms of any service contract with YFD.

1.5. RENTAL OF FIRE STATION TO MOHAVE COUNTY ELECTIONS DEPARTMENT

Hourly rate of \$50.00 with a four-hour minimum per day. No charge for drop off or pick up of equipment. Charge will be for actual hours the polling is open.
