- Use profane or vulgar language, racial slurs and/or make inappropriate comments towards my fellow teammates, umpires, other team's players/coaches/parents.
- Use any performance enhancing or illegal drugs.
- Any and all controlled substances must be prescribed by a physician
- Leave the field or a practice session without the permission of the coach
- Disregard any instruction of my coaches
- Fail to represent Texas Fury, Inc. by its expectations

- Remain in the spectator area during all indoor facility practices or outside the fence of outdoor practices/games. Tournament/League/Facility/Club rules prohibited parents/guests from entering the dugout without completion of a certified background check.

Parents will NEVER....

- Engage in dissent directed to a Texas Fury coach, an umpire, league or tournament official.
- Engage in any kind of unsportsmanlike conduct with any Texas Fury coach, umpire, league or tournament official, coach, manager, player or parent.
- Interfere at any time with the duties and responsibilities of the coaches or manager.
- Act in any way that is detrimental to the team.
- Discuss my child or any other parent's child's performance, playing time, stats or attitude with anyone other than the head coach.
- Use profanity or vulgar language, racial slurs directed at any individual while attending a Texas Fury sanctioned event.
- Consume alcohol or drugs at any time during a Texas Fury sanctioned event.

Practice Policy

- Players must arrive 10 minutes prior to practice time ready to participate
- Players must practice in the approved Texas Fury practice uniform designated by coach
- Players must come with an appropriate baseball equipment to every practice
- All Catchers must wear a protective cup, other should wear the same but assume the risk if they choose not to wear a protective cup.
- Players must bring plenty of water
- Player will be responsible for their equipment. Parents are not to help players with bags or equipment at practice or games.
- If a player arrives late or has to leave practice early, please notify the coach in advance barring exigent circumstances.
- If a player needs to miss a practice, the coach or manager must be notified in advance of the missed practice. Missing practice could/will effect players playing time in games.
- Players are allowed to practice and/or guest play with other teams/clubs in the club (Check with both coaches first)
- Parents are requested to stay out of the Dugout and off of the field during all sanctioned events unless requested by the Coach/Team Manager. In the event of an injury, the coach will request the parent.
- Parents are requested to cheer and support, but **NOT** coach or instruct their child during any practice, camp, lesson, and/or games etc.

Game and Local Tournament Code of Conduct

- Players must arrive at the game field from 30 minutes before each game.
- Players must arrive properly and uniformly dressed.
- Players are to bring adequate water with them to the game and be kept in the dugout.
- Players can only be instructed by their coaches during the game. The parent's role is strictly encouragement and as a fan.
- If a player will be late for the game or had to leave early, please notify the coach in advance barring exigent circumstances.
- During the games, parents should refrain from making any comments to the game officials. The umpires and tournament directors should always be dealt with in a professional and courteous manner.
- Every coach, player and parent must conduct themselves according to Texas Fury Code of Conduct, league, and tournament rules.
- Parents are requested not to approach the dugout during the game to talk to a coach or player. If the parent is needed due to an injury, the coach will request the parent's attention. This will help keep the team focused and ready to play at all times.
