## OLD BUSINESS

### Road Report

We have a discrepancy on Paz's invoice to repair Mosquito Lane. His estimate was to cut the tar, replace culvert with 44 foot culvert, install 2 aprons, backfill with pit run class 5, pack and pave and haul out 3 loads. We were billed \$3,200 for the repair but aprons were not installed as the original culvert did not have aprons so \$300 was deducted for that, but he does not mention repaving the repaired area. We need the talk to Paz about the repaving of the repaired area.

After discussing the issue at length, we decided to consult with Laura from Leuthner's office on our next steps.

### Second Plow Operator

Shane Wiederholt agreed to be our second plow operator this winter. His contract will run from 12-1<sup>st</sup> through April 30<sup>th</sup>.

### Horseshoe Lane Rip Rap

We are still workin on getting this done. The DNR permit states that we have until December 2022 to get the rip rap in place.

Snow removal at Town Hall

Northstar will be responsible for snow removal at the hall this year.

NEW BUSINESS

Andes Road

Lynn Bushard talked with the County Engineer and he didn't have an opinion on it. He said that County Road 107 was originally a township road that Moe and Urness townships paid the County to take the road over back in the 1980's.

Ultimately the county commissioners decide but we need to petition them to take the road over.

Solar and Wind Power Township Ordinance

The board discussed the solar/wind power ordinance that Laura had prepared for us.

New Shop and Sale of Old Shop

The board discussed possibly selling the old shop and building a new one at the site of the town hall.

Polling Place
