1. It is understood that Alex Bowlin Photography and Videography is the exclusive Videographer and/or Photographer retained by the client to cover outlined event. Any conflicts with other photographic and/or video coverage contracts and any notifications necessary to avoid such conflicts are the sole responsibility of the client.

2. Client assumes all responsibilities for obtaining any necessary permission, clearance permits, etc., which may be required for Alex Bowlin photography and videography to photograph/video each event, public or private. Client assumes all responsibility for obtaining and retaining permission for access to any requested camera positions and is solely responsible for the quality of the final production resulting from the use of, or inability to use, such camera positions.

3. Alex Bowlin photography and videography reserves the right to use videos and photos for display and or promotional purposes. All video masters, raw footage and photographs remain the exclusive property of Alex Bowlin Photography and Videography.

4. Artistic Style. On its own behalf and on behalf of the subject: Client acknowledges that he/she is familiar with the Company's portfolio and is requesting services with knowledge of the company's style and that the Company's work is constantly evolving; that the Company's services are of a unique and artistic nature; that the photos and or video may be different from photos and or video done by the company in the past; and that in creating the photos or videos we shall use our own creative artistic judgment to create images consistent with our personal judgment to create images and videos consistent with our vision of the event, which may be different from the clients and or the subject's vision of the event. Accordingly, client acknowledges that the photos or videos shall not be subject to rejection on the basis of taste or esthetic criteria.

5. The client reserves the right to terminate the contract for any reason up to 5 days after the date of down payment. Should the client terminate the contract, all money paid minus the retainer which is 50% of total cost will be refunded, if cancellation is within 30 days of wedding refund will not be available. Retainer fee to hold placement of wedding date is \$450 which is to be paid upon booking, the second half of the retainer fee is due within 30 days after. In case of natural disaster, pandemic or state of emergency retainer is non-refundable.

6. All personal property provided by client to Alex Bowlin photography and videography for utilization in the post- production of their videotape/photos is received by Alex Bowlin photography and videography at the complete and total risk of the client. Alex Bowlin photography and videography will make every effort to ensure the safekeeping of a client's personal property while in its possession and return same to client upon delivery of the edited photos.

7. Alex Bowlin photography and videography produces all photos on an online album through Pixieset that will be delivered to clients email. It is the clients responsibility to download photos at high resolution quality as this is how they are exported and placed in the online album.

8. All photo packages come with printing rights to all digital photos taken by Alex Bowlin Photography and videography. Prints are not apart of this contract, if discussed at a later date a separate contract will be established.

9. Preview photos of wedding will be provided within a week of after wedding date, minimum of 10-15 to be displayed for client to view. Full album will be completed and uploaded with 4-8wks.

10. Photo packages include the following photo amounts. *if more photos are captured above agreed minimal amount that photographer deems adequate for client, these will be provided to client at an extra cost of \$25 per 100 extra photos

□12hr package- 600-700 photos

□10hr package- 500-600 photos

□8hr package- 400-500 photos

□6hr package- 200-300 photos
