## **BYLAW RULE ON MEETINGS**

## MEETINGS

SECTION 1. An annual meeting of the voting members of the State Organization shall be held in the spring of each year prior to April 30 at a time and place selected by the President and the Board of Directors. At the annual meeting the members shall elect Directors to the Board, it shall elect the Nominating Committee and shall receive an annual report of the President and Treasurer and conduct such other business as shall usually be held in conjunction with the regular convention of the State Organization. The Biennial World Convention Delegates shall be elected at the annual meeting. Each delegate shall have an alternate. World Board members, Area Council members nor the State President shall be elected.

SECTION 2. Special meetings of the State Organization may be called by President or 20% of the voting members of the State Organization and convened only to consider one or more items of business specified in the call of the meeting. Notice of time, place and exact purpose of the meeting must be mailed to all Board members a reasonable number of days in advance.

SECTION 3. The voting members of the state Organization shall be:

A. The members of Board of Directors.

B. One delegate for a club of six (6) through twelve (12) registered members, two (2) delegates, from each club having thirteen (13) registered members, and one (1) additional delegate for each additional twelve (12) registered members or major fraction thereof. Each delegate should have an alternate.

C. The final date for determining club membership count for voting at annual conventions is January 31.

SECTION 4. A quorum at the annual and special meeting shall be a majority of the registered voting members.
