Active vouchers will be collected and applied to term 2 & 4 invoices. Creative vouchers will be collected and applied to term 3 invoices.

#### **ADDITIONAL COST**

<u>Concert Costume Fees</u> - 2021 Concert Costume Fees are due no later than the end of week 7 term 1. Final due date 21st March. After this time parents will have missed the order cut off. Costume fees will range from \$55 - \$75

This price range varies based on many factors

- exchange rate
- Shipping costs
- Import duties
- Traditionally our younger students costumes are \$55-\$65 and teen students are \$65-\$75. We will do our best to keep costumes in the lower price ranges.
- Costumes may be paid one at a time via try booking.
- The same costumes will be used in the competitions.

<u>Production Fee</u> - This fee will include your child's backstage concert costs, staff, props, stage rehearsals etc, and a <u>copy of the filming of the concert via link which can be shared with</u>

<u>family</u>. If you wish to purchase an additional DVD this can be done directly with the production company. The production fee will be added to your term 2 invoice.

1 child \$70, 2 siblings \$100, 3 siblings \$120. This is a saving to previous years where parents would purchase a DVD in addition to the production fee.

RAD BALLET EXAM STUDENTS - Examination fee, due in June/July for October & November exams. You can find exam fees on the RAD Aus website under RAV fees.

A one off hire fee of \$30 to be paid in term 4 invoice for exam leotard, hair accessories, prop, character skirt, exam number.



#### TERMS & CONDITIONS FROM 1st JANUARY 2021

- I understand that by signing this contract, I agree to follow the terms and conditions of C5 Dance Studio and that this is a legally binding agreement.
- I understand that enrolment is for a full calendar year, following the four school terms.
- I understand that my enrolment & registered classes roll over each term and I do not need to re enrol.
- I understand that withdrawal needs to be in writing prior to the first start date of a new term, in order to not be invoiced and to open a spot for another child. Failure to do so will result in 20% payment of the total owing of your term invoice.

#### Fees and payment policies

- I understand that enrolment fees are final, non refundable or transferable.
- I understand that my fees are to be pre-paid each term via direct bank transfer.
- I understand class term fees are non refundable or transferable after week 2 (or equivalent) of each term in the event of withdrawal from a class or the school.
- I understand that my child cannot commence a term of classes until fees are paid.
- I understand that my spot will be held for seven days after the fees due date, after this time I forfeit placement and registration is deactivated.
- I understand that if the school is to close due to Covid19/pandemic/acts of god related incidences, that remaining classes for the term will move online and I will not receive a refund, credit or make up studio lesson.
- I understand that in the event of a long term shut down transitioning into a new term, I will not be forced to continue online in the new term. I have the option to join a discounted online package and schedule or pause my enrolment until the studio reopens.
- I understand that it is my responsibility to contact the school if I do not wish to return after a shut down and failure to do so will result in 20% payment of the total owing on your term fees.

- I understand that I cannot pay in cash or via credit card and that I must pay via bank transfer.
- I understand that it is my responsibility to know my banking transfer times and will allow enough time to have fees paid on time.
- I agree that I will use my INVOICE NUMBER ONLY as reference when paying fees.
- I understand that only in the event of an immediate family members death will I receive credit for the required time off needed to be with family and mourning.
- I understand that only MAJOR illness requiring hospitalisation, surgery and long term recovery of 4 or more weeks will receive a credit on term fees. A doctors certificate is required.
- I understand that it's my responsibility to contact C5 Dance Studio if I am experiencing hardship and require assistance.

#### - Studio policies to comply with covid safety restrictions:

- I understand that health policies may change based on government restrictions and guidelines.
- I understand that if my child is unwell or showing flu like symptoms that they are not to return to the studio until well.
- I understand that I must report immediately if my child or family member have contracted Covid19.
- I understand that if a member of C5 dance studio has contracted Covid19 that I will be contacted immediately and that the school will close for two weeks and move online.
- I understand that there is no longer a C5 reception/waiting area until further notice, all correspondence is to take place via email and I must arrange a meeting if I wish to see someone in person.
- I understand that my child can only use the bathrooms as change room if they are capable of dressing themselves.
- I understand that there is no lost property and any items left at the studio will be thrown away (in accordance with Covid Safety restrictions placed on indoor activities).
- I understand that C5 Dance Studio is a uniform only school and that my child **must wear the correct C5 uniform and shoes** in order to participate in class. This includes all teens and seniors. In the cooler months students may wear the C5 jumper, C5 long sleeve top or a black crossover \*Our uniform is just like wearing a uniform to netball/football/soccer.
- I understand that my child must wear their hair in a neat and tidy, sleek plait or bun. This is a requirement of all good quality dance schools and is an extension of the uniform and a sign of respect to the teach, studio and fellow class members.
- I understand that my **child is not to bring food or eat whilst** at the studio or outside (in accordance with Covid Safety restrictions placed on indoor activities). Only students who attended 3-4 classes on a Saturday and have a designated break may pack a lunch and will be contacted regarding where to have lunch.
  - I understand that my child is to practice social distancing and clean hand and good hygiene whilst inside or outside the studio, and that it is my responsibility to inform and remind my child that dancing schools have different restrictions to school and social gatherings. (I'm accordance with government restrictions related to the dance school industry).
  - I understand that only a water bottle, shoes required and dance clothing in one dance bag are to be brought

to class.

- I understand that C5 is a phone free environment and my child is not to use their phone during or in between classes. And that it is my responsibility to relay this information to my child. I understand my child's phone will be taken from them if used during class and returned at the end of the lesson.
- I understand that it is my responsibility to know the drop off areas for my child's classes (please refer to drop off/pick up document that you will receive prior to starting, which will clearly outline each studios designated area).
- I understand that students only are to enter the student zones.
- I understand that siblings, parents, grandparents, guardians or friends are not to pass the student only zones, are not enter the building/studios, are not to use bathrooms at the studio (in accordance with Covid Safety restrictions placed on indoor activities).
- I understand that I am to practice social distancing or to wait in my car upon pick up and drop off and that we are to wait outside the student zones.
- I understand that my child must arrive 5 mins prior to class, they are to wait in the student zone, and will use sanitising before entering the studio.
- I understand that there will be a class lock out 5 mins after class commences.
- I understand that I cannot be late to pick up my child, continuous late pick ups (after the third occasion) will receive a service charge of \$1 per min. Staff have other commitments they need to attend and cannot supervise children after class.
- I agree that I will practice safe driving and parking upon drop off and pick up and will not put others in danger. This includes speeding, reversing down streets, double parking, parking across driveways or turning areas so that others cannot pass.

#### **Codes of conduct**

- I understand that C5 has a zero policy to rude, aggressive and passive aggressive behaviour both in person and via email, social media. Parents and students failure to adhere to this will result in losing your place at C5.
- I understand that I cannot approach a child, parent or resident neighbour in a rude or aggressive nature. Failure to adhere to this will result in losing your place at C5 Dance Studio
- I understand that it is my responsibility as a parent to stay up to date with information and that I will not take my frustration out on C5 staff. And if my child is absent from class that it could result in going off stage for portions of the concert routine
- I understand that I must get things in on time and in the event that I don't that my child will miss out.
- I understand if my child is rude to staff, fellow students or uses any form of bullying that they will no longer be able to attend C5 dance studio. \*Please note C5 has a zero tolerance to any form of bullying.
- I understand that C5 Dance Studio is try to provide a great experience for its students, in a positive and thriving environment. If I as a parent/guardian are having a bad day I will not bring that energy to the studio.
