Call to Order: Meeting was called to order at 6:30 p.m. Chair Caroline Murphy presided. The opening statement was given. Notices were properly published and posted.

5. Ordinance 12/19/22A(2022) Adopting the Wisconsin Municipal Records Schedule.

The ordinance was recommended by the Wisconsin Towns Association (WTA) at this year's annual conference. The town attorney reviewed the draft ordinance and did not recommend any changes. Motion by Phil Durrant, seconded by Craig Nelson to adopt Ordinance 12/19/22A(2022) Adopting the Wisconsin Municipal Records Schedule. Motion carried on a unanimous voice vote.

6. Ordinance 12/19/22B(2022) Governing Dances, Dance Halls and Liquor Establishments.

Waupaca County rescinded Chapter 13 regarding the governance of dances, dance halls and liquor establishments based on the inability of the sheriff's department to enforce it county-wide. It was recommended that municipalities adopt a local ordinance to enforce these events and locations. The draft ordinance was reviewed by the town attorney. Motion by Phil Durrant, seconded by Craig Nelson to table the item until the January 16, 2023 meeting to allow for review before action taken. Motion carried on a unanimous voice vote.

The resolution was another recommendation by the WTA for guidance on the documentation of the Board Meeting Agendas and Minutes. Motion by Phil Durrant, seconded by Craig Nelson to approve Resolution 12/19/22(2022) Town Policy for Board Meeting Agendas and Minutes. Motion carried on a unanimous voice vote.
