Police Department Report

A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmembers Tzan, Keedy, Karpiak and McIntire and Mayor Lincoln. The majority of the votes being affirmative, the resolution was adopted.

Resolution No. 11-8-2016: "To introduce Bill No. 5 of 2016, AN ORDINANCE OF THE CITY OF CONNELLSVILLE, FAYETTE COUNTY, PENNSYLVANIA, SHOWING THE ESTIMATED RECEIPTS, EXPENDITURES, AND LIABILITIES OF EVERY KIND FOR ALL THE FUNDS FOR FISCAL YEAR 2017 WITH THE BALANCE OF UNEXPENDED APPROPRIATIONS AS

THE BASIS FOR FIXING THE LEVY AND TAX RATE FOR SAID FISCAL, YEAR APPROPRIATING THE VARIOUS AMOUNTS SHOWN AS PROPOSED EXPENDITURES HEREIN FOR THE EXPENSES OF THE CITY FOR SAID FISCAL YEAR FROM THE REVENUE AVAILABLE FOR SAID FISCAL YEAR FOR THE DEPARTMENTS, BUREAUS, AND SPECIFIC PURPOSES SET FORTH HEREIN, AND THE REPEALING OF ALL ORDINANCES OR PARTS OF ORDINANCES INCONSISTENT HEREWITH."

Mayor Lincoln thanked the City Clerk, Councilman Keedy and Cassie and Joyce. Everyone worked hard to put this together.
