those previously addressed in the Master Agreement Article XXIV. All other terms and	
conditions shall remain in full force and effect except for those addressed here. Addendum	
applies to work performed by	_ with written consent by the office of
the Business Manager/Secretary Treasurer of IUPAT DC 51.	

- 1. Article III (Classifications & Definitions):
 - a. There shall not be a classification of Apprentice. Any worker classified as anything, but a Journeyperson will be classified as:
 - i. Helper Level 1
 - ii. Helper Level 2
 - iii. Helper Level 3
 - iv. Helper Level 4
- 2. Article VI (Out of Geographic Jurisdiction Work)
 - a. Said Addendum shall not be effective outside the Jurisdiction territory of the Union.
- 3. Article XVI (Hiring Procedure)
 - a. Section 1. The union may maintain a register of applicants for Employers signatory to this agreement.
- 4. Article XXI (Trust Funds, Contributions, Collections and Securities)
 - a. Section 6. Finishing Trades Institute of Maryland, Virginia, Washington, D.C. and Vicinities
 - i. There shall not be a classification of Apprentice. The term of Apprentice shall be changed to "Helper" while working is being performed under this addendum.
 - ii. There shall not be a Journeyperson to Helper ratio, as Addendum shall not be utilized on Davis Bacon or Prevailing Wage projects.



- 5. Article XXVIII (Hours of Work, Holidays and Overtime)
 - a. Section 2. All overtime shall be paid at the rate of time and one-half. This shall include work performed on Sundays, and on holidays.
 - b. Section 6. This section shall be exempt.
- 6. Article XXIX (Wages and Fringe Benefit Contributions)
 - a. See attached Wage & Fringe document
 - b. Section 3. Ten-minute coffee break shall be exempt for this addendum.
 - c. Section 6. Shall be exempt for this addendum.
 - d. Section 13. Shall be exempt for this addendum.
 - e. Section 14. Shall be exempt for this addendum.
 - f. Section 15. Shall be exempt for this addendum
- 7. Article XXX (Work Conditions)
 - a. Section 7. Shall be exempt for this addendum.
