##### Road Report

## NEW BUSINESS

### Truck Repair Supplies

Knowing that the strobe light on one of the trucks was inoperable, Jerome Kostreba found on an online state auction site, MNbid, 2 pallets of equipment. 1 pallet contained emergency flashers, rotating beacon, lenses, and other related repair parts, which Jerome was able to purchase for \$86.10. The second pallet contained parts for Ford and Sterling trucks, such front springs, rear springs, vibrator motor, sand spreaders and many other parts for \$75.81. With the parts on the first pallet we were able to repair the strobe light. A motion was made to reimburse supervisor Kostreba for these parts in full (m- Lynn Bushard, s- John Krafthefer) Jerome Kostreba abstained.

### Trim or Remove Trees in ROW

We received 2 quotes to remove trees in the ROW on Twin Point Circle and Twin Point Lane. Joe's Cutting Edge quoted \$5,000 and Kronberg Tree Services quoted us \$7,500. We will mark the trees we want removed and ask both to rebid it.

### Battery Operated Chain Saw

We had purchased a battery operated pole saw last year. We are now looking to get a battery operated chain saw of the same manufacturer so the batteries are interchangeable. To purchase the chainsaw and 1 battery from Alex Power would cost \$320. A motion was made to purchase the battery operated chain saw from Alex Power for \$320. ### Rodent Control Shop

A motion was made to have Plunkett's setup at the shed to control the rodent population. (m- Jerome Kostreba, s- John Krafthefer, v- unan)

### Emergency Siren

We continue to have maintenance issues with the siren. The batteries are constantly going bad. We just replaced them in February now they are telling us they are bad again.

### Roof Town Hall

We will get a couple quotes to reroof the hall. We will be looking at both steel and asphalt options.

### Fall Spray Hall

The hall has already had the fall invader spray performed.
