5. DISCUSSION OF THE SALE OF THE SOUTH TREATMENT PLANT:

Mayor Horton discussed the details of the letter from Balar Engineers which summarizes the three options in which the council may choose concerning the Palmetto Wastewater Treatment Plant. The Bossier Parish Police Jury has offered the Town \$ 1.6 million to purchase the system (excluding the treatment plant). The following is a summary of the three options:

- (a) Take no action and continue to operate and maintain the system and the treatment plant. Future maintenance is expected and in order to make that investment rates will have to be raised to offset the costs.
- (b) The Town can have a certifies appraiser evaluate the treatment plant, lift stations, collection system and convey all components of the system and present the offer of sale to the Police Jury.
- (c) The Town can negotiate a contract with the Police Jury to receive and treat the wastewater flows. Rates will need to be increased to offset the costs for treatment by the Parish. This will continue to generate income for the Town.
