Liz opened meeting with a prayer.

Minutes: Bonnie motioned, Bill second to approve minutes of last meeting, accepted.

Treasurer: Carla Ingalls sent treasurer's report. Bill motioned, Mary second to approve, accepted

Paul Messmer has been appointed as our new pastor and will start August 1st, with the 4th being the first Sunday in the pulpit. Mary is his wife's name.

## Food Pantry:

Church Mutual is working on a document for working with the Food Pantry as the hosting site only. Liability will fall on the Food Pantry.

Barbara Certa-Warner, the new District Superintendent has communicated with Dawn Rank (Food Pantry). Dawn, Jennifer Heidtke and one other person will meet for the audit of the Food Pantry. Liz will be contacting Roger Sharp and Rog Paulson for one of them to be the other person.

Will need a certificate of insurance coverage from Dawn.

Barbara Certa-Warner also working on document for facility use agreement that will need a trustee signature as well as the entity using the building.

All the above to be done before new pastor's arrival.

#### Finance:

No meeting, but need to be ready for budget preparation.

Also we would like a periodic announcement from the pulpit on where we (this church) stands.

We are at the halfway point now so a report can be made by Bonnie. Would like one every quarter.

## SPRC:

Letter announcing new pastor to be in Newsletter.

Charge office has been moved physically to Holcombe, now we need to organize the office space. According to the D.S., Pastor cannot use nursery as office and pastor and assistant should not share office space. The subcommittee on space use will meet again to address these issues. Subcommittee of Bill, Mary and Cheri as well as Jennifer. Pastor has expressed wishes to buy home on the lake.

### Worship:

Will be using the bulletin covers we have (multiple), so Sunday bulletins will be different.

#### Missions

No meeting, but will be having the Baby Bottle coin collection the month of August.

#### Kitchen:

Supply check list to be made for easier notice of needs and for purchasing.

As for food, if the family wishes, --we are working on setting up a system to determine what we are able to offer. Mary will contact a church she knows that has a program in place that works for them to see if that is what will work for us. It can be catered in to church now.

#### Lions Club bake sale:

September 9th they will be having the Car Show and Chicken Dinner. The bake sale monies will be going for the new facility addition to accommodate the Food Pantry. We would like this congregation to help with baked goods, --pies, bars, cookies-- individual portion size packages. As well as purchasing the dinner and baked goods.

## Trustees:

Sue will be contacting blacktop contractors for estimates so we have a target price, but due to the high cost of this project, there is need to have a fundraiser.

Will contact Bob Zamskey to replace North door of garage.

Hanging of banners in sanctuary-- The hooks on rails like in the hallway was unapproved, but free standing banner hangers that can be easily made and move around met with approval.

Patio area for placement of picnic table and benches, -- we decided against Southside of garage as the area would need to be too big to accommodate the table, benches and tree. A suggestion by Ray of removing ground cover in corner by office and using that place will be looked into as well as other placements.

Ray again went over need to leave thermostats set at right temps and to only move to cool as needed or in winter to warm. And to use occupied when many persons are in the building. And to turn to off when leaving the building. Cheri mentioned a group had all the doors opened due to being too cool and left back door unlocked.

Spraying of weeds has been done. We need to set date of annual clean-up day to remove weeds and such outside, wash windows and general cleaning inside.

#### WIFI:

Aron motioned for Jennifer to change password monthly, second by Bonnie to deter use by outsiders. She will the email Ad Council members of new password. Accepted. Also can set up so WIFI cannot be used outside of building.
